SUBJECT: To Recognize the Exiled Kashmiri Pandit Refugee and Asylee Population in Montgomery County, Maryland on January 19th

Background

- 1. On the night of January 19, 1990, the Kashmiri Pandit population were exiled from their homes, which led to their ethnic cleansing from the Kashmir Valley. This day is observed globally by the Kashmiri Pandit community every year, a day of mourning the loss of their lives, homes, livelihoods, language and culture.
- 2. Today, Montgomery County and the State of Maryland are home to one of the highest Kashmiri Pandit diaspora populations in the world and many of its Kashmiri residents have contributed to our County and country as doctors, entrepreneurs, scientists, and engineers, and in education and innovation.

Action

The County Council for Montgomery County, Maryland approves the following resolution:

- 1. Montgomery County affirms January 19th to be the Kashmiri Pandit Remembrance Day and recognizes the minority refugee and asylee population of Kashmiri Pandits who have overcome incredible atrocities and challenges since 1990.
- 2. Montgomery County recognizes the Kashmiri Pandits' sacrifices and contributions to our local society.
- 3. The Council affirms the County's ongoing commitment to cultivate an inclusive, safe, and just society and culture that values the diversity of our community, works to ensure equitable opportunities in all major facets of society, and celebrates both our individuality and commonality.

It is important that the plight of the Pandits be given attention so that those empowered to protect them can do the right thing.
