

- Racial Equity Impact Assessment (REIA) Supplemental Appropriation (SA) #23-56 -Re: Amendment to the FY23-28 Capital Improvements Program for Wheaton Arts and Cultural Center
- I. FINDING: The Office of Racial Equity and Social Justice (ORESJ) finds that Supplemental Appropriation #23-56 – Amendment to the FY23-28 Capital Improvements Program for Wheaton Arts and Cultural Center – has a strong likelihood to advance racial equity and social justice in the arts and cultural sector, while also providing equitable access to a public good that is enjoyed in other parts of the County. This project will also increase the availability of affordable housing in and around the Wheaton Central Business District plan area.
- II. **BACKGROUND**: The Wheaton Arts and Cultural Center project provides funding for site evaluation and design to build a new arts and cultural facility that will sit within the Wheaton Arts and Entertainment District. The mission of the project is to create a center to serve the artistically varied and active arts community and to cultivate the diversity of the arts in Wheaton by enhancing the cultural and educational opportunities for community participation in the arts<sup>1</sup>. The new arts and cultural facility will be co-located with an affordable housing development. Supplemental Appropriation #23-56 will fund the County's share of the schematic design and the sketch plan submission to M-NCPPC. Montgomery Housing Partnership (MHP), the County's affordable housing development partner will be submitting a Low-Income Housing Tax Credit (LIHTC) application in May

2023 and design is required prior to submitting the LIHTC application. A project amendment has also been requested in the FY24 budget submission<sup>2</sup>. The updated project schedule shows construction of the facility occurring in FY27 and beyond.

III. <u>ANALYSIS</u>: ORESJ developed a Capital Improvements Program Budget Equity Tool (CIP BET) and Guidance Manual<sup>3</sup> to help stakeholders in Montgomery County incorporate a racial equity lens into CIP project development and resource decisions. Best practices for using a racial equity tool, such as the CIP BET, suggest that the tool should be used early and often in project development and involve a diverse set of project stakeholders—including community members and intended beneficiaries of the project. The Wheaton Arts and Cultural Center project was reviewed during the FY24 review process using the CIP BET framework and received five stars, indicating the project *strongly* aligns with Montgomery County's policy to reduce and eliminate racial disparities and other inequities. Within the context of the CIP BET framework, we offer several observations for consideration:

# What racial disparities or inequities in Montgomery County does this project seek to reduce or eliminate?

In 2018, the County engaged a consultant to conduct an arts and cultural feasibility study. The first phase of the feasibility study produced preliminary findings and recommendations for a new arts and cultural center in Wheaton<sup>4</sup>. The second phase of the feasibility study produced a programming and business plan for the envisioned center<sup>5</sup>. During the study, the consultant engaged the community in a robust engagement phase. Activities included one-on-one interviews, focus group discussions, town hall meetings, e-surveys, arts organizations engagements, and site visits<sup>6</sup>. Many of the engagement activities were conducted in English and Spanish. More recently, the Department of General Services (DGS) provided the Wheaton Urban District Advisory Committee with a project update<sup>7</sup>.

The study found that while many spaces exist throughout the County, there was no dedicated space for arts or cultural activities or performances in Wheaton. The results of the study indicated the following needs: an arts facility; space to professionally develop artists and arts organizations; studio space, performance space, creative space; and space where the community can gather and participate in the arts. Family programming, programming for children, teens, and young adults were also identified as a need. The study was used to produce a program of requirements (POR), which was completed in FY20.

ORESJ has previously analyzed racial inequities impacting the public arts field. The full analysis can be found in REIA 22-67 Public Arts Trust, available here: <u>https://www.montgomerycountymd.gov/ore/Resources/Files/22-67.pdf</u>. The REIA points to research suggesting that a focus on empowering oppressed groups and redistributing resources has the greatest potential of advancing racial equity. By deploying resources to Wheaton to develop an arts and cultural center, the County will provide both resources and opportunities to reduce racial inequities in the arts for an underserved population.

This project also will increase the number of affordable housing units in the County as MHP will partner on the project to create affordable housing on the premises. The County Council recently passed Bill 33-22 – Capital Improvements Program – Affordable Housing Feasibility Study – Required. DGS is now required to provide the Council with an affordable housing feasibility study for certain capital projects. Although the Wheaton Arts and Cultural center project was initiated before the Bill was enacted, it illustrates the potential for co-location of County facilities and affordable housing to reduce racial disparities in housing insecurity, such as rent burden and homelessness for Black and Latinx residents<sup>8</sup>. ORESJ has previously reviewed housing policy, including the historical and contemporary racial inequities shaping housing insecurity and homelessness in several REIAs. ## How does this project address the racial disparities and inequities you described?

The Wheaton Arts and Cultural Center will be located in the Wheaton CBD and Vicinity Sector Plan area–placing the center within a central transportation hub and crossroads. The Wheaton population is diverse, with over 75% of residents being non-white and 45% of the population identifying as Hispanic or Latino<sup>9</sup>. The study also found income disparities in

the area, with 61% of residents within a 20-minute drive time radius earning less than \$75,000. A link was noted in arts participation levels and available discretionary money, highlighting the need for subsidy programs to bridge the gap between arts activities and audience affordability.

# Does this project (including its development, construction, or implementation) have the potential to create any unintended consequences?

Once the project nears completion and an operator is selected, there are several considerations that could affect the center's ability to reduce racial inequities in the arts. These challenges were identified during the planning stages by the consultant<sup>10</sup>. The challenges identified include:

- Identifying a qualified facility operator with programming experience to activate the goals of the arts incubator
- Establishing a philanthropic program for the facility to cover the operating expenses and to fulfill the annual budget requirement
- Maintaining an active calendar of events
- Creating an equitable and inclusive use-policy that will allow access for a diversity of users
- Establishing and implementing methods for measuring the impact of the facility on Wheaton artists and the community overall

The consultant noted, that as the project progresses, the facility "must consider Wheaton's Spanish-Speaking population and explore opportunities for reaching the target audience base when developing new programming". While outside the scope of this REIA, a racial equity lens should continuously be applied throughout the development process, especially during the RFP process for operator selection and for arts and cultural programming and operations of the facility.

## Background

- Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of six Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of seven Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. Section 302 of the Montgomery County Charter provides that the Council may amend an approved capital improvements program at any time by an affirmative vote of no fewer than six members of the Council.
- 3. The County Executive recommends the following capital project appropriation increases:

### PROJECT DESCRIPTION

This project provides for planning, site feasibility, and design activities for a new arts and cultural facility to be located in the Wheaton Arts and Entertainment District. The project's specifications, including the potential for affordable housing, will be evaluated for the selected site.

### ESTIMATED SCHEDULE

Funds through FY23 will be used for planning and site feasibility work. Placeholder funding for design is included in FY25.

#### COST CHANGE

I am pleased to transmit to you, in accordance with the County Charter, my Recommended FY24 Capital Budget and amendments to the FY23-28 Capital Improvements Program (CIP). This is the biennial, or second year, of the biennial capital budget. As a result, amendments are limited to project changes that either meet the County's CIP amendment criteria, or that are necessary to address capital or operating budget constraints.

The attached CIP amendment recommendations take advantage of opportunities to leverage non-County resources and reflect our shared values of prioritizing education and core infrastructure while considering racial equity and climate change concerns. These amendments are all affordable within available resources. That being said, I am painfully aware that, without more funding, we are limited in our ability to solve local problems and to build the kind of healthy, just, economically vibrant community we want for our residents.

#### **Overall Fiscal Context**

High inflation due to supply chain issues, labor shortages, and a tight construction market has had a major impact on the biennial CIP. Montgomery County Public Schools projects were particularly impacted. Less than a month after the CIP was approved last May, MCPS requested a \$12 million supplemental appropriation for the Neelsville Middle School Major Capital project to proceed with planned construction. MCPS' biennial CIP request included \$103 million in cost increases to keep eight planned projects on schedule. Similarly, the County's Dennis Avenue Bridge, 6th District Police Station, Public Safety Communications Center Phase II upgrades, Recycling Center Complex Upgrade, Damascus Library Refurbishment project, Purple Line related projects, and Stormwater Management projects would require approximately \$24 million

more in funding if they were to proceed with planned FY23 and FY24 construction. Nine percent State cost escalation allowances for Montgomery College's Library Renovations and Germantown Student Services Center projects added over \$17 million in additional cost pressures.

Projects to maintain core infrastructure and operations detailed below also added to the significant cost pressures that need to be addressed in the biennial CIP.

On the revenue side, the most dramatic change in CIP funding sources occurred in recordation tax receipts. Based on updated estimates, the Recommended CIP assumes the use of \$468 million of recordation taxes and \$114 million of recordation tax premium funding – a \$138 million reduction in CIP funding compared to prior approved estimates. On a positive side, school and transportation impact tax revenues are projected to increase by over \$35.8 million primarily due to construction cost related rate changes and the allocation of some prior year unused collections. Land sale proceeds (\$29.5 million) and General Obligation bond premium (\$20.5 million) have also helped mitigate the impact of the shortfalls in recordation taxes.

I am recommending a total of \$1.72 billion in General Obligation bond issuance over the sixvear period - \$40 million more than the current Spending Affordability Guideline limits. While I am maintaining the Council approved \$280 million funding level in FY23 and FY26 to FY28, I am recommending a modest increase in FY24 and FY25 to \$300 million a year to respond to a change in conditions affecting State Aid for school construction.<sup>1</sup> The chart below compares my recommended General Obligation Spending Affordability Guidelines with Council's most recent actions regarding General Obligation Bond limits and spending.

MCPS staff have already been informed by the Interagency Commission on School Construction (IAC) that due to higher interest rates, MCPS' allocation of Built to Learn State Aid for school construction has shrunk from \$378 million to \$357 million - a \$21 million decrease. The impact of higher interest rates coupled with high construction cost inflation is eroding our ability to execute long planned school projects that are ready to move forward. I hope that you and your

The 2019 Montgomery County Racial Equity profile reported that due to structural racial inequities, Black residents were 145.6 percent more likely than White residents to take public transportation. By supporting expansion of the County's transit operations which have historically benefitted communities of color, the depot is likely to support racial equity and social justice goals.

#### Lactation Rooms in County Buildings

As a result of Bill 11-22, *Lactation Rooms in County Buildings*, that I proudly signed into law on July 26, 2022, County law now requires at least one lactation room for County employees in each existing County building, including a sink with running water and plumbing systems or with nearby access to running water. This new project will fund an assessment of all County-owned and leased facilities as well as improvements needed to comply with the law's requirements. An FY23 supplemental appropriation request and CIP amendment is being sent under separate cover to fund the facility assessment study and initial construction.

#### Elizabeth Housing Demolition

The South County Regional Recreation and Aquatics Center (SCRRAC) is being built as part of the Housing Opportunities Commission's (HOC) Elizabeth Square mixed-income, multigenerational, mixed-use development. This new project will provide HOC with half the requested funds to demolish their current Elizabeth House public housing development prior to further redevelopment of the site and the opening of the SCRRAC. The remaining demolition costs will be covered through a long-term loan from the Department of Housing and Community Affairs and HOC funds. Demolition of the building this spring/summer will result in lower operating costs for HOC and ensure safe, easy access to SCRRAC patrons.

#### **Other County Government Project Enhancements**

#### Wheaton Arts & Cultural Center

I am also particularly pleased that we have been able to secure a partner to make our dreams of a Wheaton arts facility a reality. The County has selected Montgomery Housing Partnership's (MHP) proposal to combine an affordable housing development with a new, County-funded arts center in the Wheaton Arts and Entertainment District. MHP has an agreement with Montgomery County Parks to swap a former WMATA-owned land parcel on Georgia Avenue with MHP's Amherst Square Apartments on the east side of Elkin Street. MHP will develop the former WMATA site with two affordable rental buildings with 280 units, a standalone garage, and 40 affordable, for sale units. The arts center will be included on the ground floor of the first rental building fronting on Georgia Avenue. The center will include two performance spaces, classrooms, gallery space, back of house support space, and administrative offices. In addition,

once MHP develops the former WMATA site, Parks will redevelop the Amherst Square Apartments site with a new community park.

This project must proceed at this time so that MHP can apply this year for low-income housing tax credits from the State to maximize housing affordability. Without committing to the project this year, we risk losing this opportunity to co-locate affordable housing with an attractive community amenity. In order to minimize the financial impact to the CIP, I have assumed that buildout of the interior space will be funded in FY29; however, I am pursuing State funding for the project to expedite the interior build out.

When evaluating this project, the Office of Racial Equity and Social Justice noted the community engagement process involved in determining the need for an arts and culture space in Wheaton. They also indicated that the project has a strong likelihood of advancing racial equity in the arts and culture sector, while also providing equitable access to a public good that is enjoyed in other parts of the County.

#### Preservation of Naturally Occurring Affordable Housing (NOAH)

My Recommended CIP also includes a \$30.2 million increase in the Preservation of Naturally Occurring Affordable Housing (NOAH) project. Using \$40 million appropriated last May, the NOAH project has already used \$33.7 million to help close on a \$44-million Right of First Refusal deal for Scarborough Square and used \$1 million for a Schuyler Avenue project with a commitment to provide the remaining funds to the Housing Opportunity Commission's Battery Lane project. Together, these projects will preserve 118 affordable housing units. In addition, the project has already generated \$30.2 million in loan repayments, which will be made available for additional lending.

As a technical matter, I would also ask that the County Council approve a provision that allows for the automatic reappropriation of the Preservation of NOAH project loan repayments as the Council has done with the Affordable Housing Acquisition and Preservation project. This will facilitate a more rapid use of these funds to support affordable housing developments.

The Office of Racial Equity and Social Justice recently noted that the Preservation of NOAH project was "designed with inequities related to housing cost burden for low-income households, specifically households of color," in mind. ORESJ noted that the project "targets resources towards helping residents in well-established/older communities avoiding displacement created by rising prices."

#### Resurfacing Parking Lots: MCG

I am recommending an FY23 \$125,000 supplemental to make parking lot improvements at the former Hillandale Elementary School parking lot. These improvements will allow the East

Unfortunately, due to the cost pressures and revenue shortfalls mentioned above, it was necessary to delay the following projects for fiscal reasons: White Flint Fire Station 23; Outdoor Firearms Training Center; Bradley Boulevard (MD 191) Improvements; Capital Crescent Trail; Falls Road Bikeway and Pedestrian Facility; Forest Glen Passageway; Goldsboro Road Sidewalk and Bikeway; Tuckerman Lane Sidewalk; Observation Drive Extended; Summit Avenue Extension; and Chevy Chase Library and Redevelopment.

#### **Project Savings**

Prior year savings were realized from a number of projects including <u>Americans with Disabilities</u> <u>Act (ADA) Compliance; White Flint Redevelopment Program; County Radio Replacement and</u> <u>Related Equipment; Montgomery County Detention Center Partial Demolition and Renovation;</u> PSTA Academic Building Complex; and the Silver Spring Lot 3 Parking Garage.

#### **Racial Equity and Climate Change**

As part of the FY23-28 Biennial CIP process, the Office of Management and Budget (OMB) assisted the Office of Racial Equity and Social Justice (ORESJ) in developing a budget equity tool to encourage departments and decision makers to consider the racial equity and social justice impacts of proposed projects, project amendments, and budget decisions. ORESJ staff conducted training and provided technical assistance to departments as they requested CIP amendments. In addition, racial equity was considered in assessing possible CIP additions and deferrals. Where possible, efforts were made to hold harmless projects which could address racial disparities.

In their analysis, the Office of Racial Equity and Social Justice also noted ways in which different approaches to implementing projects could impact racial equity. This input is useful to continuing conversations about how programs can be structured to achieve our racial equity and social justice goals.

Biennial CIP project changes that have the greatest potential to advance racial equity and social justice include the \$30.2 million increase in the <u>Preservation of Naturally Occurring Affordable</u> <u>Housing</u>; additional High School Wellness Centers in the highest need schools; the <u>Wheaton Arts</u> <u>and Cultural Center</u>; <u>Digital Equity – Montgomery Connects</u> grant funding to bring broadband to affordable housing complexes; school construction projects serving communities primarily comprised of Black, Latino, and low-income students; and Montgomery College projects.

My Recommended CIP includes \$1.4 billion in funding for projects that advance our Climate Change goals. As previously noted, my Recommended CIP includes additional funding to provide a full upgrade of the County's recycling center, and funds have been included for planning and design for a new Transit maintenance depot to accommodate an expanded fleet and Recommended FY24 Capital Budget and Amendments to the FY23-28 Capital Improvements Program (CIP) January 17, 2023 Page 12 of 14

low emission vehicle maintenance and fueling/charging facilities. Funding for new HVAC systems for the Executive Office Building, the Judicial Center, and the 4<sup>th</sup> District Police Station will improve energy efficiency. Fiscal constraints also led to deferrals in a number of pedestrian/bicycle facility projects.

#### Need for Additional Resources

In the not so distant past, the County had more resources to support the capital budget. As recently as FY18, the County was issuing \$340 million a year in General Obligation debt. And, over my objections<sup>2</sup>, the prior Council approved changes to the Growth and Infrastructure Policy (formerly known as the Subdivision Staging Policy) which, at the time, were expected to, respectively, reduce schools and transportation impact taxes by \$9.5 million and \$3 million a year.<sup>3</sup> As noted above, our constrained resources are limiting our ability to achieve our educational, environmental, transportation, housing, economic development, and community enhancement goals. While my staff and I are aggressively pursuing State and federal funding opportunities, partnerships that leverage the resources of others, and creative financing mechanisms, I hope that we can collectively explore other local funding options.

#### Set-Aside Considerations

Set-asides are annual funds that the County intentionally leaves unprogrammed to provide capacity to respond to unexpected needs and opportunities. The recommended capital budget assumes a six-year \$151,212,000 set-aside with \$25,322,000 available in FY23 and FY24. There are several projects that will be updating cost estimates in the coming months that may need to tap into these funds.

#### Supplemental Appropriation Requests

I will be sending, under separate cover, the following FY23 Supplemental Appropriations and CIP Amendments: <u>EOB/HVAC Renovation; HVAC/Elec Replacement: MCG; Lactation Rooms</u> in County Buildings; Resurfacing Parking Lots: MCG; 6<sup>th</sup> District Police Station; <u>Public Safety</u> Communications Center, Phase II, Electrical Distribution and HVAC Upgrade; Streetlighting; Ag Land Pres Easements; Wheaton Arts and Cultural Center; Preservation of Naturally Occurring Affordable Housing Fund; WSSC Sewer and Storm Line Improvements at Elizabeth Square; and <u>Elizabeth House Demolition</u>.

#### Dear Mr. Elrich,

Wheaton Arts Parade greatly appreciates your leadership and commitment to the arts in Wheaton by including funds for an arts center in your FY24 Capital Improvements Budget. We are writing to urge you to consider the views of Wheaton's artists, arts organizations, and businesses before making a final decision on the location for the arts center. More than 200 residents and businesses have signed the attached petition and that number only increases as more become aware of this issue.

Your recent public comments indicate that you have selected a site on the outskirts of Wheaton because of cost and expediency and that you rejected a site in Wheaton's core business district because it is too small. We call your attention to the fact that the size requirement for your site selection has been based on a false assumption that the arts center must have two performance spaces on the ground floor. We understand that this was recommended by your consultants back in 2019, but that requirement was never weighed against the benefit of having only one performance space if the arts center could be located near the Metro.

It is unlikely that an arts center in the selected location will attract any audiences by Metro. Your own planning department has found that both Georgia Ave and University Blvd act as barriers to pedestrian traffic. Audiences, therefore, will be arriving by car and will need to compete with MHP residents for parking spaces in the evenings. Meanwhile, the county parking garage under the MNCPPC headquarters will be underutilized in the evenings.

The proposed design for the arts center lacks any studio space for visual artists, dancers, or musicians and there is no plan for a gallery separate from the stage lobby. Your consultants identified studio space as the highest priority for local artists.

But of greatest concern to Wheaton residents and businesses is whether the proposed location for the arts center will stimulate economic activity in Wheaton. An arts center located near the Metro Station would stimulate business at restaurants and retail establishments and create an anchor for a night time economy. There is not a business anywhere near the selected site that will benefit from the arts center being placed there.

All of the above are reasons to question whether the county's vision for the arts center is shared by the community. What are we trying to accomplish with an arts center in Wheaton? The stated

purpose of an arts and entertainment district is economic development. If a location closer to the Metro would accomplish that, it is worth considering a layout that would fit in Parking Lot 13.

Is the purpose of an arts center to provide venues to attract professional performers and artists, and audiences from outside Wheaton, or is it to provide a place for local amateur art makers and performers? Doesn't the Recreation Center already provide space for community activities dancers, artists, potters, fabric artists? This question needs to be addressed and answered by the county government in consultation with the community so that we move forward knowing that we have a shared vision for the purpose of the arts center.

We urge you to make the future economic development of Wheaton the highest priority. What will Wheaton look like in 30 years if we build an arts center on Lot 13 versus up on Georgia Ave near the Rec Center? If the county doesn't take this opportunity to inject economic activity into the Core District, then what alternative development is planned? We urge you to recognize that this is a once in a decade opportunity to help Wheaton develop its core. It will even help the county attract tenants to its own vacant commercial space on Reedie Drive.

If the county has \$20-40 million to add to the MHP project, please consider the alternative of making those funds available to a developer willing to build on Lot 13 and devote the first two floors to the Wheaton Arts Center. If money is the only reason the county isn't willing to build a 2-story arts center, then why isn't the county willing to raise funds the way they were raised for Strathmore, by attracting donations from philanthropists and by selling naming rights.

The most important thing to realize is that if \$40m is spent on the wrong location, Wheaton will not have a second chance to make the most of that investment. We urge you to reconsider your decision and to allocate sufficient staff and contractor resources to build a shared vision with the community that fully investigates the options for an arts center in the core business district near the Metro.

Dear County Executive Elrich and Montgomery County Council Education & Culture Committee,

On behalf of the Wheaton Urban District Advisory Committee (WUDAC), we wish to express our support for the CIP amendments relating to the proposed Wheaton Arts and Cultural Center. Specifically, we support the FY23 amendment to support the site selection process and the FY23-26 amendment supporting the design and construction of such a facility.

As you are aware, Wheaton is an established Arts and Entertainment District, one of 3 designated by the State of Maryland in Montgomery County. Wheaton is home to one of the most diverse communities in the country, yet we have no real established home to display the wide variety of arts that represent our community. This is an opportunity to formalize the creation of this potentially world-class facility, and we strongly urge this Committee and the Council as a whole to support these CIP amendments.

As you are probably aware, the development of this project has been years in the making. Your previous colleague Councilmember Navarro, the County Executive and many of you sitting council members have publicly voiced your support for such a facility in Wheaton. Not only is this an opportunity to provide additional performance and visual arts facilities in this part of the County, it is imperative that we also recognize and continue to activate the traditional and ethnic arts that enrich our community. This is an opportunity to showcase the unique and diverse traditional and ethnic arts that are represented by our community, similar to what has been done by the Smithsonian in Anacostia.

As you may be aware, the Arts and Humanities Council of Montgomery County (AHCMC) established the Wheaton Cultural Grants, which helped to activate the community, and that grant fund continues to grow. The Wheaton Arts Parade and Festival provides an opportunity to showcase these arts and artists, and its popularity continues to prove the business case that there is support for an established facility to nurture and display these artists' talents.

While the support for a Wheaton Community Arts and Culture Center is almost universal, as you may be aware, there are some community concerns regarding the potential location and design of the project. By supporting the FY23 CIP amendment, or even increasing the amount dedicated to the site selection process, your vote will allow for additional current community input and design suggestions. By supporting the FY23-26 amendment for design and construction, you will formalize the project and allow for additional fundraising efforts with the State and other non-profit granting organizations.

There are two items that we wish to address:

It could be more economically beneficial to place the facility closer to the downtown core to support a more vibrant 24-hour economy in the heart of the central business district. It would be more advantageous to support the restaurants and other small businesses if there were an opportunity to collaborate with a developer to create a facility closer to the Metro. This might be possible if the project were a multi-floor facility or a "campus" type of development. Realistic options should be explored during the site selection process funded by the CIP amendment.

The Consultant's reports and the resultant Program of Requirements (POR) were conducted prior to the recent pandemic. It is important to update the POR to reflect new trends in utilization post-pandemic and moving forward. Additionally, the demand for affordable rental rehearsal and performance space in the entire Washington Metro Area continues to increase dramatically, helping to ensure a more viable financial model. The consultants recommended creating an "artist incubator," and the lack of dedicated visual arts gallery or studio space or enough classrooms, and the absence of any maker/fabrication space, seems to ignore these recommendations. If affordable housing is a component, it would be desirable to accommodate affordable artist housing in the project.

In summary, WUDAC supports the approval of both CIP amendments regarding the Wheaton Arts and Cultural Center. We also request that additional funding be included in the FY23 amendment to support additional community input, reevaluation of the POR and supporting assumptions, and to provide an opportunity to update based on the impact of the pandemic. Regardless of final site selection (including the proposed WMATA/MHP location), design issues including additional floors, access, pedestrian safety and post pandemic trends must be addressed. However, this process does not necessarily need to slow down the project since the CIP amendment allows for additional design discussions. Now is the time to formalize this project in the CIP and use the next few months to conduct serious community engagement with all parties involved to maximize the benefits to the community.

We hope that the Committee and the Council concur that an Arts and Cultural Center in Wheaton is a desirable project that should be continued, and that it moves toward a more equitable expression of support for our community. If the County is to treat Wheaton equitably in relation to a functioning Arts and Entertainment District, it is imperative to create a facility that satisfies the ever-growing need of local and regional artists in multiple genres, now and in potential future creations.
