DESCRIPTION/ISSUE

The County Executive has requested a special appropriation of \$1,319,629 for the State Opioid Response (SOR) III grant. The grant will fund screening, examination, behavioral health treatment, and medication assisted treatment. It will also fund reentry plans and services in collaboration with the Department of Correction and Rehabilitation and the Sheriff's Department for eligible offenders with a diagnosis of opiate use disorder as they move through the Montgomery County Correctional Facility.

The State Opioid Response (SOR) III, \$1,319,629

I am recommending a special appropriation to the FY23 Operating Budget of the Department of Health and Human in the amount of \$1,319,629 for the State Opioid Response (SOR) III grant. This appropriation will fund the assessment and treatment of inmates who are not already receiving Medication Assisted Treatment services upon sentencing to the Montgomery County Correctional Facility.

This increase is needed because the State of Maryland Behavioral Health Administration (BHA) provides these funds for screening, examination, behavioral health treatment, and medication assisted treatment. This grant will also fund reentry plans and services in collaboration with the Department of Correction and Rehabilitation and the Sheriff's Department for eligible offenders with a diagnosis of opiate use disorder as they move through the Montgomery County Correctional Facility.

I recommend that the County Council approve this Special Appropriation in the amount of \$1,319,629 and specify the source of funds as the State Grant.

Background

- 1. Section 308 of the Montgomery County Charter provides that a special appropriation: (a) may be made at any time after public notice by news release; (b) must state that the special appropriation is necessary to meet an unforeseen disaster or other emergency or to act without delay in the public interest; (c) must specify the revenues necessary to finance it; and (d) must be approved by no fewer than six members of the Council.
- 2. The County Executive has requested the following FY23 Operating Budget appropriation increases for the Department of Health and Human Services:

- 3. This increase is needed to support the implementation of House Bill 116 Medication Assisted Treatment in the Jail. The grant will fund screening, examination, behavioral health treatment, and medication assisted treatment. It will also fund reentry plans and services in collaboration with the Department of Correction and Rehabilitation and the Sheriff's Department for eligible offenders with a diagnosis of opiate use disorder as they move through the Montgomery County Correctional Facility.
- 4. The County Executive has requested a special appropriation to the FY23 Operating Budget in the amount of \$1,319,629 for the State Opioid Response (SOR) III grant and specifies that the source of funds will be State grant.
- 5. The public was notified by a news release.
