COMMITTEE RECOMMENDATIONS

Concur with the Executive's recommendation.

SUMMARY OF KEY ISSUES

The Executive recommends \$2,400 more than in the FY23 Operating Budget, which pays for the County's share of costs associated with the parking garages in the Rockville Town Center. The share is associated with the free use of several garage spaces for County employees working in the Rockville Memorial Library. The budget is formula-driven, based on an MOU between the County and City approved two decades ago, so the proposed increase would not go on the Reconciliation List. This reimbursement to the City of Rockville has three components:

- The annual debt service payment of \$180,000 is unchanged from the FY23 Budget.
- The charge for Rockville Library employee parking is \$99,600, which is also unchanged from the FY23 Budget.
- The Payment in Lieu of Taxes (PILOT) is \$142,700, \$2,400 more than the FY23 Budget.

** Risk Management (General Fund)

This NDA funds the General Fund contribution to the Liability and Property Coverage Self-Insurance Fund. The Self-Insurance Fund, managed by the Division of Risk Management in the Department of Finance, provides comprehensive insurance coverage to contributing agencies. Contribution levels are based on the results of an annual actuarial study. Special and Enterprise Funds, as well as outside agencies and other jurisdictions, contribute to the Self-Insurance Fund directly.

Rockville Parking District

This NDA provides funding towards the redevelopment of the City of Rockville Town Center and the establishment of a parking district. The funding reflects a payment from the County to the City of Rockville for County buildings in the Town Center development and is based on the commercial square footage of County buildings.

Also included are funds for the cost of library employee parking and the County's capital cost contribution for the garage facility as agreed in the General Development Agreement.

Skills for the Future

The Shalls for the Future Non-Departmental Account was established in May 2019 to provide funding for high-quality Science, Technology, Engineering, Arts, and Mathematics (STEAM) programming in both academic and recreational settings to low-income youth.
