A. The County Executive's FY24 recommended operating budget for the Office of Human Rights totals \$2,059,712, an increase of \$423,806 or 25.91% from the FY23 approved budget. The Executive recommends 12.1 FTEs for the Office of Human Rights in FY24, an increase of 1 PTE from FY23. Personnel costs comprise 79.6% of the budget, operating expenses comprise the remaining 20.40% of the budget. The changes included in the Executive's recommendation are summarized below:

- Add \$56,000 for the Remembrance and Reconciliation Commission

- Add \$40,000 for the Community Reinvestment Act Initiative

C. FY24 Recommended Budget Changes (with no Service Impacts)

- An increase of \$54,945 for an FY23 compensation increases
- An increase of \$53,822 for FY24 compensation Adjustment
- **Restore \$40,000** for Ban-the Box Campaign
- An increase of \$17,951 for the annualization of FY23 personnel costs
- An increase of \$2,500 for the Biennial Hall of Fame Event
- An increase of \$207 for printing and mail

MISSION STATEMENT

The Mission of the Office of Human Rights is to enforce the County's anti-discrimination laws in housing, commercial real estate, employment, public accommodations, and intimidation. The Office also provides training, public education programs, and promotes the increased understanding and tolerance among diverse groups.

BUDGET OVERVIEW

The total recommended FY24 Operating Budget for the Office of Human Rights is \$2,059,712, an increase of \$423,806 or 25.91 percent from the FY23 Approved Budget of \$1,635,906. Personnel Costs comprise 79.60 percent of the budget for 11 full-time position(s) and one part-time position(s), and a total of 12.10 FTEs. Total FTEs may include seasonal or temporary positions and may also reflect workforce charged to or from other departments or funds. Operating Expenses account for the remaining 20.40 percent of the FY24 budget.

COUNTY PRIORITY OUTCOMES

While this program area supports all seven of the County Executive's Priority Outcomes, the following are emphasized:

- Thriving Youth and Families
- Effective, Sustainable Government

INITIATIVES

- Hosting the Annual Human Rights Agencies Training Conference in August 2023, in partnership with the International Association of Official Human Rights Agencies (IAOHRA).
- Continue implementation and outreach efforts of Ban-the-Box laws that prohibits employers and housing providers from asking applicants about criminal history on job or housing applications.
- Planning and coordination for the County's Juneteenth Celebration, the observance of November as the month of Remembrance and Reconciliation, and other activities focused on mitigating the incidents of hate violence in the County.

INNOVATIONS AND PRODUCTIVITY IMPROVEMENTS

Human Rights General Government 36-1

- ** Planned and coordinated the first two-day Juneteenth event as the County celebrated its first official holiday observance with an estimated 4,000 people in attendance.
- ** Coordinated with the Remembrance and Reconciliation Commission the observance of November as the month of Remembrance and Reconciliation in the County. Activities focus on the recognition of three men lynched in Montgomery County in the late 1800s: George Peck, John Diggs Dorsey, and Sidney Randolph.
- ** In accordance with the Community Reinvestment Act (CRA) created a minority business training and development program in conjunction with the Human Rights Commission and a private bank. The ten-week intensive program has had 70 small businesses successfully complete the program.
- ** Held the second in a three-part series in partnership with the US Equal Employment Opportunity Commission, "A Virtual Employer Summit", focused on age discrimination and the multigenerational workplace, including corporate, academic, and federal enforcement officials as presenters.

Office of Human Rights Explanations to Council Staff Questions

1. Add: Funding for Juneteenth and Reverend Dr. Martin Luther King, Jr. Celebrations \$70,000.00

Juneteenth

- For FY23 the Office requested \$100,000 in the CE recommended budget, however it was not approved by Council. Funding was subsequentially obtained from the Office of Human Rights personnel savings for vacant positions (which have since been filled), which transferred \$50,000 to the operating budget to provide funding for the Juneteenth event.
- The Juneteenth Celebration will be a 2-day event starting Friday evening with the African American Living Legend Event and other activities planned all-day Saturday.

Dr. Martin Luther King, Jr. Celebration

• There was no funding allocated for the FY23 MLK Celebration in the FY23 budget. The Office relied on funding provided from individual departments and external funding sources (i.e., grants through the Volunteer Center).

2. Add: Funding for the Remembrance and Reconciliation Commission \$56,000.00

• This was deferred last year. "Due to fiscal uncertainty, defer the consideration to January 2023 of one-time operating expenses totaling \$56,000 to support the FY23 activities of the Montgomery County Commission on Remembrance and reconciliation". (See HHS Committee Worksession Staff Report, April 14, 2022).

3. Add: Funding for Hosting Human Rights Agencies Conference \$40,000.00

• Note: This is one time.

4. Add: Funding for the Community Reinvestment Act (CRA) Initiative \$40,000.00

- In FY23 there was a 10-week program, which resulted from a CRA related complaint against M&T Bank. The allegation claimed that minority businesses were not receiving federal assistance through the Paycheck Protection Program (PPP) program provided during the COVID-19 pandemic. The PPP program provided payroll assistance to businesses which was administered by banks. The program is still underway, and we graduate our third cohort on next Monday. To date nearly 200 minority businesses have completed the 10 week comprehensive program.
- The FY24 funding will support opportunities for ways the County can leverage the resource of area banks in the affordable housing and other economic development

opportunities, which is part of the enforcement of the fair housing law as part of the Community Reinvestment Act requirement for all banks.

5. Restore funding for Ban-the-Box \$40,000

• In FY23, funding for the Ban-the-Box campaign was decreased due to fiscal constraints. However, the Office was tasked to enforce the ordinance of the EEO laws for Ban-the-Box in Housing and Employment, officially the Fair Criminal Record Screening Standards in employment (Bill 35-20) and the Fair Criminal Record Screening Standards as amended (Bill 49-20). Restoration of funding in the FY24 budget is required for Ban-the-Box education and outreach campaigns.

6. Increase Cost: Biennial Hall of Fame Event \$2,500.00

• The FY22 Biennial Hall of Fame event was budgeted at \$7,500 and there has been no increase in costs. The event is held every two years in the fall or early winter and the Office allocates \$2,500 as a deposit for the venue and other services in the off year. The remainder of the costs are budgeted in the calendar year of the actual event. For instance, the Office will budget the 2024 event at \$5,000 in FY25.

Dear Chair Albomoz and Councilmembers Luedtke and Sayles,

In advance of the HHS Committee's budget discussion on Monday, April 17, regarding the Office of Human Rights, I am writing to express my strong support for restoring that office's funding for the Ban-the-Box campaign to help ensure that members of our community with a criminal record are able to obtain housing and employment.

The Office of Human Rights is responsible for enforcing the County's Ban-the-Box laws related to housing and employment, namely as enshrined in Bill 35-20 (Human Rights and Civil Liberties - Fair Criminal Record Screening Standards — Amendments) and Bill 49-20 (Human Rights and Civil Liberties - Discrimination in Rental Housing - Fair Criminal History and Credit Screenings ("Housing Justice Act")), However, the funding for the education and outreach campaigns related to this work was decreased in FY23 due to fiscal constraints.

I urge the committee to support the restoration of this funding in the FY24 budget. The Office of Human Rights' work in this area is an important part of ensuring that members of our community with criminal records, including those who are reentering society after serving time, are able to do so with dignity and the best chance possible of success, a benefit for them and their families and our entire community. Indeed, it is a win for our County as a whole if these community members are able to obtain and sustain stable employment and housing, which will allow them to be productive members of our community. Please support the restoration of the funding, and please continue to keep this goal in mind as a priority moving forward.

In addition, I would ask that you look closely at the Office of Human Rights' other funding requests, for Juneteenth and Reverend Dr. Martin Luther King, Jr. Celebrations, the Remembrance and Reconciliation Commission, hosting a Human Rights Agencies conference, the Community Reinvestment Act Initiative, and the Biennial Hall of Fame event. I believe these are worthwhile, and send an important message to our community about our County's dedication to, and investment in, ensuring that the human rights for all people are protected and prioritized.

As always, I would be happy to discuss these issues with you if that would be helpful.
