**AN ACT** to:

- (1) make certain legislative findings regarding the religious, ethnic, and cultural heritage of County residents;
- (2) designate certain days of commemoration;
- (3) ~~[[require]]~~ authorize the Chief Administrative Officer to designate certain days of commemoration;
- (4) require the Chief Administrative Officer to provide certain notice to County employees regarding days of commemoration; and
- (5) generally amend the law relating to County employees and the religious, ethnic, and cultural heritage of County residents.

*The County Council for Montgomery County, Maryland approves the following Act:*

Section 1. Chapter 33 is amended by adding ~~[[Section 33-5]]~~ Section 33-4B,

Days of Commemoration:

~~[[33-5]]~~ 33-4B. Days of commemoration.

(a) Legislative findings.

(1) The religious, ethnic, and cultural heritage of County residents is very diverse.

(2) The County benefits economically, intellectually, culturally, and socially from the richness and strength of its diversity and seeks to promote an inclusive community for all residents.

(3) The County's respect for the diversity of its own workforce is reflected in the County's rules governing leave and alternate work schedules for religious observance.

(4) The ability of County employees to meet the needs of County residents and provide high quality customer service is enhanced when County employees know that certain days have special religious, ethnic, or cultural meaning that will affect the daily activities of a significant number of County residents.

(b) Days of commemoration.

(1) Each of the following calendar days is designated a day of commemoration:

(A) Eid Ul-Adha;

(B) Asian Lunar New Year;

(C) Martin Luther King Day;

(D) Ash Wednesday;

~~[[F]]~~ (G) Holy Thursday;

5                    (c) First notice to County employees. ~~[[One week before each day of~~  
 56                    commemoration or, for multi-day celebrations, the first day of

57 commemoration, the]] Once every 3 months, the Chief Administrative

58 Officer must notify all County employees [[in writing or]] electronically of

59 the [[date of the day of commemoration or, for multi-day celebrations,

60 the]] dates of [[the]] all days of commemoration that will occur in the next

61 3 months and provide:

62 (1) a brief explanation, based on a generally accepted reference source,

63 of the religious, ethnic, or cultural meaning of [[the]] each day [[or

64 days]] of commemoration and the date on which the day is usually

65 observed;

66 (2) any relevant information regarding the manner in which the daily

67 activities of County residents on the day [[or days]] may affect

68 programs and services provided by the County; and

69 (3) [[when appropriate, a greeting or salutation that may be shared by

70 County employees with County residents for whom the day or days

71 have special meaning; and

72 (4)]] for days with religious meaning, an explanation of the County's

73 rules governing leave and alternate work schedules for religious

74 observance.

75 (d) Second notice to County employees. [[The Chief Administrative Officer

76 must repeat the electronic notice required under subsection (c) on each day

77 of commemoration or, for multi-day celebrations, on the first day of

78 commemoration]] In the 7-day period preceding a day of commemoration

79 or, for a multi-day celebration, the first day of commemoration, the Chief

80 Administrative Officer must:

81 (1) notify all County employees electronically of the date of the day of

82 commemoration or, for a multi-day celebration, the dates of the

3 days of commemoration; and

84                   (2)   provide the information required by subsection (c)(1) through (3)  
85                                   regarding the applicable day or days of commemoration.

86           (e)   The Chief Administrative Officer must maintain a list of all days of  
87                   commemoration and make the list accessible to the public by posting it on  
88                   the County's website.

89           (f)   The County Executive may, by regulation adopted under method (2),  
90                   remove a day designated as a day of commemoration under subsection  
91                   (b)(1) from the County's list of days of commemoration.

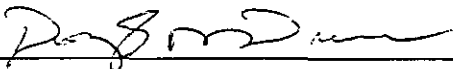
