SUBJECT: Amendment to the FY06 Operating Budget  
Resolution 15-1015, Section G, FY06 Designation of Entities for Non-Competitive  
Contract Award

Background

1. Section 11B-14(a)(4) of the Montgomery County Code states that "a contract may be awarded without competition if the Chief Administrative Officer makes a written determination that the contract award serves a public purpose and a proposed contractor has been identified in a grant or appropriation resolution approved by the Council."
2. The Chief Administrative Officer has determined that funding for the contracts with these entities serve a public purpose and that such expense would be in the public interest.
3. The Department of Health and Human Services will fund the contracts with the entities (Providers) listed below from existing appropriations for FY06.
4. The Department of Health and Human Services will amend existing contracts with the vendors listed below to correct the contract amounts based on the May 2005 reconciliation of clients and services and the Council approved Inflationary Adjustment for FY06 for these providers of services to developmentally disabled Individuals.
5. The Department of Health and Human Services will enter into a contract with the Jewish Foundation for Group Homes, Inc., to assist in the purchase of two vans to serve the organization's group homes, as originally intended by Council.

Action

The County Council for Montgomery County, Maryland, approves the following action:

The Council approves an amendment to the Designation of Entities for Non-Competitive Contract Award and thereby amends Resolution 15-1015, Section G, FY06 Designation of Entities for Non-Competitive Contract Award. The Chief Administrative Officer has recommended this action and stated that contracts with the 24 developmentally disabled service providers and the Jewish Foundation for Group Homes, Inc. serve a public purpose and are in the public interest.


The FY06 Designation of Entities for Non-Competitive Contract Award resolution is amended to:
