COUNTY COUNCIL FOR MONTGOMERY COUNTY, MARYLAND

By: Council President Leventhal

AN EXPEDITED ACT to:

- (1) exempt certain members of the Advisory Board for the Montgomery Cares Program from certain conflict of interest requirements under certain circumstances;
- (2) require these members to file limited public financial disclosure statements and publicly disclose certain information regarding conflicts of interest; and
- (3) generally amend the law governing public ethics and the Montgomery Cares Program.

By amending

Montgomery County Code
Chapter 24, Health and Sanitation
Section 24-50

1 **Sec. 1. Section 24-50 is amended as follows:**

2 **24-50. Members; appointments; terms.**

3 * * *

4 **(f) Conflicts of Interest.**

5 **(1) Section 19A-11(a) does not apply to a member appointed under**
6 **subsection (c) [[if the member:]].**

7 **(2) A member appointed under subsection (c) must:**

8 **[[(1)] (A) [[files]] file a limited public financial disclosure**
9 **statement that complies with Section 19A-**
10 **17(a)(6); and**

11 **[[(2)] (B) publicly [[discloses]] disclose to the Board the**
12 **nature and circumstances of any conflict before**
13 **voting on any Board recommendation.**


14 **Sec. 2. Expedited Effective Date.**

17 becomes law.


