Sec 1. Section 27-67 is amended as follows: 1 2 27-67. Findings and definitions. 3 (b) Definitions. As used in this Article: Director means the Executive Director of the Office of Human Rights and 5 includes the Executive Director's designee. 6 7 *Employ* means to engage a person to work for compensation. *Employee* means any person permitted or instructed to work or be present by 8 9 an employer in the County and who is an employee subject to the minimum wage requirements of the Federal Act or the State Act. 10 11 Employer means any person, individual, proprietorship, partnership, joint venture, corporation, limited liability company, trust, association, or other 12 entity operating and doing business in the County that employs [2] 1 or more 13 persons in the County in addition to the owners. Employer includes the County 14 15 government, but does not include the United States, any State, or any other 16 local government. 17 Federal Act means the federal Fair Labor Standards Act of 1938, as amended. 18 State Act means the Maryland Wage and Hour Law, as amended. Wage means all compensation that is due to an employee for employment. 19 Sec. 2. **Effective Date.** 20

This Act takes effect on July 1, 2019.
