AAC	Alcohol Awareness Certified Person – No One On Premises
ABR	Alcoholic Beverages removed from ON SALE ONLY licensed facility for use at another AB licensed facility
AFTER HOURS	Selling/serving alcoholic beverages after permitted hours
ALERT	Alcohol Law Education and Regulatory Training class given by Dept of Liquor Control – required attendance for designated

CATERING	personnel (licensees, managers, supervisors and/or employees)
CDS	Failure to comply w/catering regulations
DISP	Sale, transfer, accommodation for the sale or transfer, or possession of controlled dangerous substances on premises
DISORDERLY HOUSE	Dispensing spirits by the bottle
ELECT GAMBLING	Fighting, endangerment, public disturbance on the licensed premises
GAMBLING	Electronic gambling machines available for play found premises
KEG	Gambling or bookmaking permitted on licensed premises
ILLEGAL CONSUMPTION	Beer keg registration not properly completed
LICENSE	Allowing alcohol to be consumed on premises that was not purchased from the licensee
LICENSE DISPLAY	Treating license as property in violation of State law
LIMITS ON LIC. PREMISES	Alcoholic Beverage License not properly displayed
NFA	Sale, service or consumption of alcohol on the part of premises not licensed for such uses.
NLDS	No Food Available for Sale
NOISE/DISTURBANCE OF NEIGHBORHOOD	Not licensed to have distilled spirits on premises
OPA	Fighting, shouting, physical altercations, etc., taking place in immediate area outside of the licensed premises
OPEN CONTAINER	Outside Premises Advertising
OUTDOOR CAFÉ	Open glass or bottle of alcoholic beverage taken off premises of an "on sale only" licensee
RATIO	Failure to comply with rules and regulations regarding outdoor premises as part of the licensed premises
RATIO REPORT	Failure to comply with mandated food to alcoholic beverage sales ratio requirements
RECORDS	Failure to submit required food to alcoholic beverage sales ratio reports
REFILL	No employee records available when requested
RIV	Refilling empty or partially empty alcoholic beverage bottles
SENPE	Records/Invoices not available for inspection
SPND	Sexually explicit/nude photos exhibition
STI	Sexual Practices/Nude Dancing
STM	Sale/Service to Intoxicated Patron
STORAGE	Sale to Minor
TAMPERING	Failure to comply with storage of alcohol regulations
UNAPP SOURCE	Adulterating, diluting, or fortifying contents of alcoholic beverage bottles
UESA	Failure to purchase alcoholic beverages from Mont. Co. Dept. of Liq. Control
VIOLATIONS/TRANSFER	Underage Employee selling/serving alcoholic beverages
