Telework can provide your organization a way to address employee and management concerns, maintain or even improve productivity, and provide an effective mobility alternative during SafeTrack.

#### **Metro's SafeTrack Surge Begins in Montgomery County August 1**



As WMATA works to address safety and reliability issues throughout the Metrorail system, the Montgomery County Department of Transportation (MCDOT) is striving to help you prepare and make alternative travel plans.

**What to Expect:** Three planned line segment repairs and around-the-clock single tracking projects, referred to as "Safety Surges," will affect Metrorail Red Line service in Montgomery County during the following dates:

- August 1-7
- August 9-18
- October 10 - November 1

**Inter-Agency Cooperation:** MCDOT is coordinating with WMATA, the Maryland Transit Administration, Maryland Department of Transportation, and Capital Bikeshare to assist travelers. WMATA's first surge (Surge 6) in Montgomery County is scheduled to begin August 1.

- WMATA has committed 40 buses to enhance service in surge areas.
- Responding to a request from MCDOT, the MARC rail system will add cars to existing trains during peak periods.
- By keeping up to 17 recently replaced buses in service, MCDOT will both provide additional Ride On service on certain bus routes and free bus shuttles between affected Metrorail stations.
- Ride On will provide on-street ambassadors at affected Metrorail stations to help direct travelers to transit options.
