Item 1&2 – Introductions/Minutes: Members and guests introduced themselves. July's minutes were approved.

Item 3 – Ride On extRa Limited Stop Service: Will Kenlaw, MCDOT-Ride on, discussed the new Ride On extRa bus service starting October 2nd that will travel the MD 355 corridor from Lake Forest Mall to Medical Center Metro Station.

The Ride On system, with 850 employees and over 3,500 stops, is one of the largest suburban bus systems. Ride On serves neighborhoods and feeds into the Metrobus system that services main arteries. Ride On also provides service to seniors and disabled low income residents.

Mr. Kenlaw said the MD 355 corridor is the most congested in the county, and that an attempt to reduce traffic by adding five more buses to the route was unsuccessful. County Council funded the extRa service to increase seating capacity along the corridor and as a precursor to the Bus Rapid Transit (BRT) system:

- ExtRa will service 12 out of the 80 stops along the MD 355 corridor
- Buses will have signal priority and complete the route in 52-58 minutes vs. 1 ½ hour current runtime-buses run every 10 minutes
- Buses equipped with Wi-Fi and USB ports
- Buses will travel inside Montgomery College for safety and not inside Twinbrook & Shady Grove stations
- Shelters are equipped with extRa signage, inlaid artwork and monitors showing runtimesno backs on benches
- No loading of SmarTrip cards on buses for speedy service \$2.00 fare
- Free rides during month of October
- No changes to 46 & 55 routes
- Marketing outreach included dispatching teams, newspaper and TV advertisements, social media and presentations.
- Buses are equipped with extra padding and green branding on outside front of bus

Mr. Kenlaw explained that extRa's route runs parallel to Metro as an added transit alternative to accommodate future economic and population growth; also as an alternative (not substitute) to the discontinued J7 & J9 Metrobus routes.

Sandra Brecher discussed the status of bikeshare station installations, explaining that there are none currently at Lake Forest but coming to Twinbrook, and the challenges with Medical Center Station installation. EYA was key to station installation at Shady Grove Metro.
