Burtonsville Access Road

Introduction

Burtonsville Access Road: The project provides for the construction of approximately 1,400 linear feet of new roadway with two lanes and parking on the westbound side located in Burtonsville, Maryland. The Burtonsville Access Road begins at the Burtonsville Elementary Access Road and connects to the existing roadway and entrance of Old Columbia Pike (MD 198), for a total distance of approximately 1,400 linear feet. The new Access Road alignment will connect to existing parking lots and businesses along the corridor and will add streetlights and luminaires to this section.



Scope

The work will consist of but not be limited to the following:

- Construction of new the roadway.
- Installation of a 10-ft-wide asphalt shared-use path on the westbound side of the new roadway.
- Installation of a 5-ft-wide sidewalk on the eastbound side of the new roadway.
- Installation of 2 brick-patterned concrete retaining wall.
- Installation of Approx. 1,900 linear feet of new storm drain and new submerged gravel wetland stormwater management facility and landscaping
- Milling and Resurfacing of the existing roadway to tie in new roadway alignment

Traffic Control, Work Hours & Phase

The project will commence with the implementation of temporary construction signs and traffic control for the affected work areas. Construction is scheduled to take place Monday through Friday between 7:00 AM and 5:00 PM, possibly weekends if deemed necessary. The County will work with the Contractor to minimize disruptions to adjacent communities and businesses.

Project Highlights

- Construction: May 2025 to Summer 2026
- Construction will take approximately fourteen months to complete.
- Essential County services will continue
- to be provided.
