The Montgomery County Department of Transportation (MCDOT) is continuing planning efforts for the three related bike and pedestrian improvement projects in Fenton Village. We will provide regular updates through newsletters like this one.

UPCOMING MEETINGS

There are two upcoming meetings for the Fenton Village Bike & Pedestrian Projects. Due to the Covid-19 pandemic, both meetings will take place in a virtual setting only. Advance registration is encouraged for both meetings, so we can send log-in information directly to you.

On **September 29 from 7:00 p.m. to 9:00 p.m.**, MCDOT will present the implementation plan for Stage 1 (speed treatments) of the **Grove Street Neighborhood Greenway Pilot**. On **November 18, from 7:00 p.m. to 9:00 p.m.**, MCDOT will present the findings of the **Fenton Street Bikeway Study** and will show a set of design alternatives. An update will be provided about the **Fenton Street/MD 410 intersection project** as well. The virtual meeting will provide an opportunity for you to ask questions and provide feedback. Grove Street Neighborhood Greenway Pilot

We had a successful virtual community meeting on July 15. MCDOT received lots of feedback from residents about the treatments they were interested in seeing applied to Grove Street along with treatments they did not want to see.

It's not too late to provide feedback before the meeting. MCDOT is conducting an [online survey](#) to hear your preferences about Grove Street. That survey will remain open until 5:00 p.m. on Friday, September 4. If you haven't yet had a chance to share your thoughts with us, please take a few moments to fill out the survey.

Based on the survey and the comments we receive, our team will develop an implementation plan for Stage 1 of the pilot, which we will implement in late fall 2020. The September 29 meeting will give you a chance to weigh in on the implementation plan.

The Grove Street treatments are part of a pilot and will be interim-style treatments that can be easily removed or modified. These are not permanent treatments. In the first stage of the pilot, MCDOT will focus on speed treatments to slow down drivers. A sample of possible interim treatments are shown in the images in the sidebar.

Fenton Street Bikeway Study

We have been hard at work conducting the study of potential impacts since the January 2020 meeting. The effort is looking at how a bikeway will impact traffic and parking, how much different options will cost, and how to deal with issues in the corridor like loading and utilities.

The team is finalizing the alternatives that will be presented at our November 18 meeting and preparing to run each of them through the traffic modeling process. Each alternative will be posted on the project webpage at least a week before the meeting.

Following the public engagement process this fall, the County will select a preferred alternative to move forward into design in early 2021.

Fenton St / MD 410 Intersection Redesign

This project will result in the redesign of the Fenton Street / MD 410 (Philadelphia Ave & Burlington Ave) intersection to improve pedestrian and bicyclist safety and reduce impervious surface.

MCDOT has continued development of the hybrid option, as discussed in our previous newsletter in June. At this time, we are coordinating with the Department of Permitting Services, the Maryland State Highway Administration, and the Montgomery County Parks Department to refine the design and address concerns.

We will provide an update to this project at the Fenton Street Bikeway Study meeting on November 18.

What is a "Neighborhood Greenway?"

A "Neighborhood Greenway" is a street where the safe movement of pedestrians and cyclists is prioritized and the fast, through movement of vehicles is discouraged. Tools can include speed treatments, like speed humps and chicanes, and volume management, like diverters.
