

Goldsboro Road Bicycle and Pedestrian Improvements Facility Planning Study in Progress

The safe and efficient accommodation of pedestrians and cyclists on public road facilities is just as important as accommodating cars and vehicles. The Montgomery County Department of Transportation (MCDOT) believes sidewalks and bike facilities enrich the livability of a community and serve as critical links in the transportation network by providing pedestrian and bicycle access to neighborhoods, transit, commercial districts, schools, parks and other recreation areas.

Accordingly, MCDOT's Division of Transportation Engineering (DTE) initiated a Facility Planning, Phase I Study to evaluate the need for sidewalks and on-road bike facilities along Goldsboro Road from MacArthur Blvd. to River Road (MD 190) and reconfiguration of the MacArthur Blvd. intersection providing safe pedestrian access to several transit stops, Glen Echo Park, connectivity to neighborhoods, and improve bicycle access along the corridor. The Goldsboro Road Project was initiated as a result of a request from the Tulip Hill Citizens Association for greater pedestrian access along Goldsboro Road.

GOLDSBORO ROAD

Goldsboro Road is an undivided two-lane two-way roadway with a posted speed limit of 35 mph. The roadway is located in a predominately single-family residential community in Bethesda, Maryland, east of

Glen Echo Park, with relatively small commercial centers at just east of the Massachusetts Ave intersection and just north of the MacArthur Blvd intersection. There are limited pedestrian facilities along Goldsboro Road. The only continuous sidewalk is along the southern side of the roadway, from Tulip Hill Terrace to approx. 1/4 mile east of Massachusetts Ave. Goldsboro Road is served by Ride-On Route 29.

MASTER PLAN RECOMMENDATIONS

Goldsboro Road is identified in the 1990 *Bethesda-Chevy Chase Master Plan* as two-lane arterial A-84 from MacArthur Blvd. to Massachusetts Ave. and as two-lane major highway M-93 (MD 614) from Massachusetts Ave. to River Road. The 2005 *Countywide Bikeway Functional Master Plan* proposes on-street bike lanes BL-1 along Goldsboro Road.




What is Facility Planning?

Facility Planning for transportation improvements is an evaluation process that furnishes design plans which are approximately 35% complete. It is managed in two phases. Phase I addresses two essential questions:

- What will the improvements be?
- Why are the improvements necessary?

Phase II addresses:

- How will the improvements be performed?
- How long will the design/construction take?
- How much will the improvements cost?

The components of both Phase I and II provide enough information for elected officials to determine whether or not the project is justified to be fully funded for design and construction.

What stage is the Goldsboro Road Bicycle and Pedestrian Improvements Project?

The Goldsboro Road Bike and Pedestrian Improvements Project is in Phase I of the Facility Planning Process, which is the beginning of the analysis. Phase I generally provides 15% design and involves:

1. Collecting background data, reviewing the Master Plan and identifying pending developments within the project limits;
2. Obtaining public input;
3. Developing concept plans;
4. Preparing preliminary cost estimates; and
5. Selecting a Recommended Alternative.

What happens after this workshop?

Your comments and concerns will be taken into consideration as the Study Team refines and finalizes various concepts. The concept that best addresses the project's purpose and need and the concerns of the community will be selected as the Recommended Alternative. A newsletter informing the community of the Recommended Alternative will be mailed to the public.

Who receives this newsletter?

The newsletter is mailed to Home Owner Associations representing the subject Study Area and property owners directly abutting the subject roadway whose names appear on the County's Geographical Information System (GIS) database. The Life of a Transportation Project

FACILITY PLANNING-PHASE I

Collect data, obtain public input, develop concept plans, evaluate and select preferred alignment/cross section. Obtain Director's and Montgomery County Council's Transportation Infrastructure, Energy and Environment committee (T&E) approval.

FACILITY PLANNING-PHASE II

Develop 35% design plans, cost estimates and project schedule. Submit to County Council for approval to include in Capital Improvement Program (CIP).

FINAL DESIGN AND CONSTRUCTION

If approved for full funding and is included in the Capital Improvement Program (CIP), complete final design and construction.



PROJECT PROSPECTUS

The *Project Prospectus* is the culmination of the Phase I Planning Study, documenting the evaluation of concepts, analysis of impacts, and participation and comments from the public and other stakeholders. The *Project Prospectus* is anticipated to be completed and made available online at the project website in August 2014.

FACILITY PLANNING PHASE II

Once the *Project Prospectus* is approved, the Goldsboro Road Pedestrian and Bicycle Improvements project will advance to Facility Planning, Phase II.

A new MDCOT Project Manager will be assigned, and he/she will continue open dialogue with the public and all stakeholders. During the Phase II process, 35% design plans will be developed, as well as a detailed schedule and cost estimate. Phase II for Golds-



boro Road Pedestrian and Bicycle Improvements is estimated to be completed in Summer 2016.








