## **Grosvenor BiPPA Project Construction Newsletter**

## Project to Begin in late-April 2025, weather permitting.

This newsletter is to inform you of the upcoming installation of the Grosvenor BiPPA project, which provides for the installation of a sidewalk and shared-use path along MD 355 (Frederick Road) from Pooks Hill Road to Strathmore Avenue.

### **BACKGROUND**

The Grosvenor project is part of the County's Bicycle-Pedestrian Priority Area Improvements (BiPPA) program, which provides for the design and construction of pedestrian and bicyclist improvements identified in County master plans.

### **SCOPE OF PROJECT**



Please visit the project website to view the 100% design plans. The 3. Excavation for Drainage and Signal Improject includes signing, marking, geometric, drainage, and signal improvements.

## **SCHEDULE**

This project is scheduled to tentatively begin in late-April. Weather permitting, the project will take approximately 4 to 6 months to complete. Work hours will be between 7am and 5pm, Monday through Friday.

## PROJECT WORK PLAN



Generally, the work will proceed as follows:

## Tree Removal

Any trees slated for removal will be removed tentatively in late-April. Construction may take place simultaneously. No parking signs will be placed around the subject trees prior to removing.

# 2. Markings in Right of Way & No Parking

Sidewalk locations will be marked out in white paint in the public right-of-way. No parking signs will be erected along the limits of sidewalk installation. Please do not park on your driveway on the day of installation. Thereafter, please allow 24 hours for the material to cure. Thank you.



## provements and Setting of Sidewalk/Shared-**Use Path Forms**

The excavation will begin for drainage and signal improvements, sidewalk and path construction and the placement of concrete forms for the pouring of the sidewalk, shared-use path, leadwalks and driveway aprons, if applicable.



4. Pouring of Concrete/Alernative Material Once the new sidewalk or path has cured, the forms will be removed and topsoil, seed and straw will be added to backfill to meet with existing grade.

## Sealant

A sealant will be sprayed upon the new sidewalks, shared-use path, and driveway aprons to preserve and protect the new infrastructure from harsh winter chemicals.
