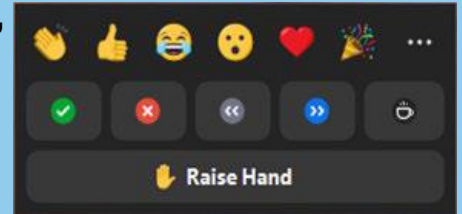

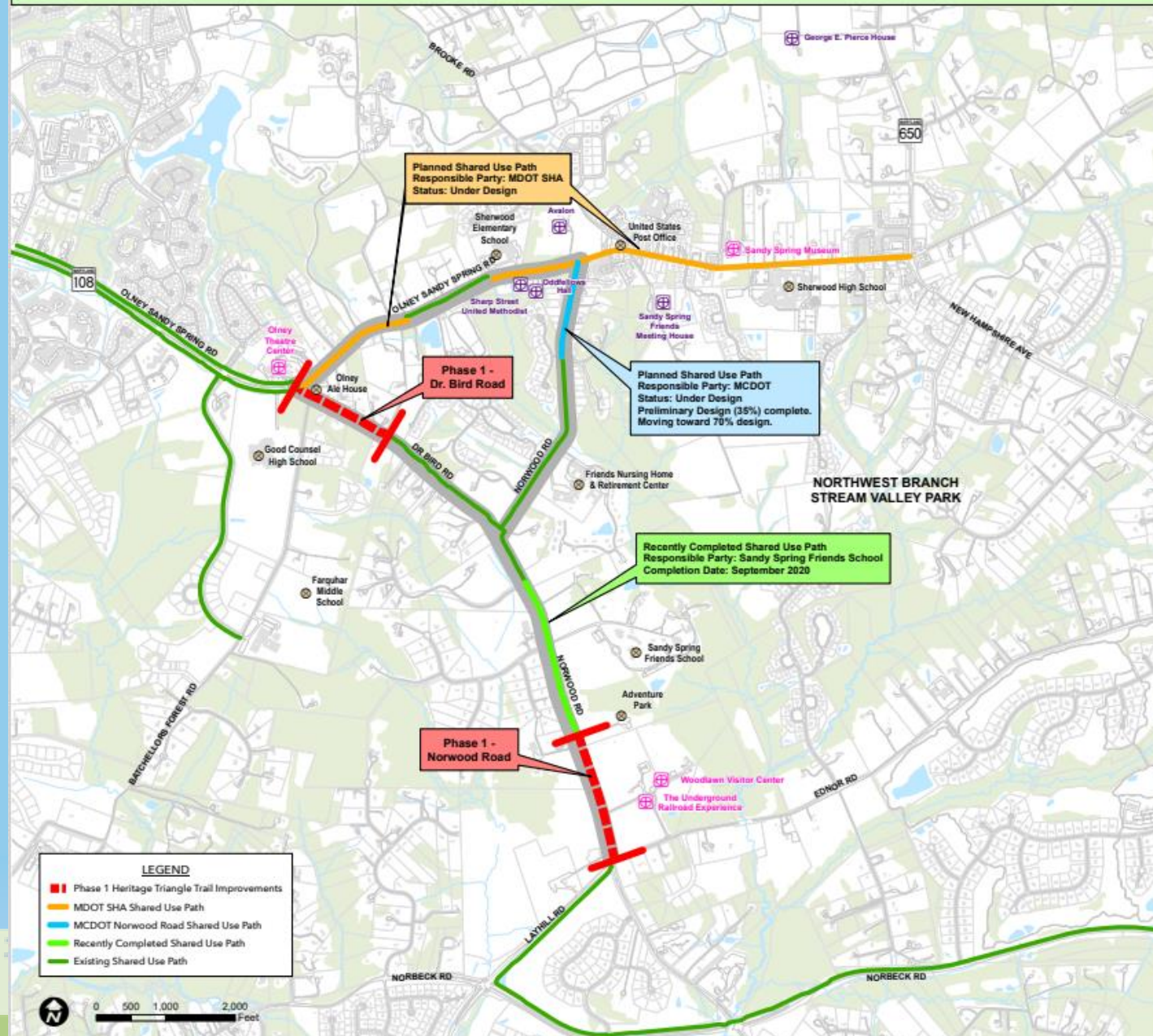

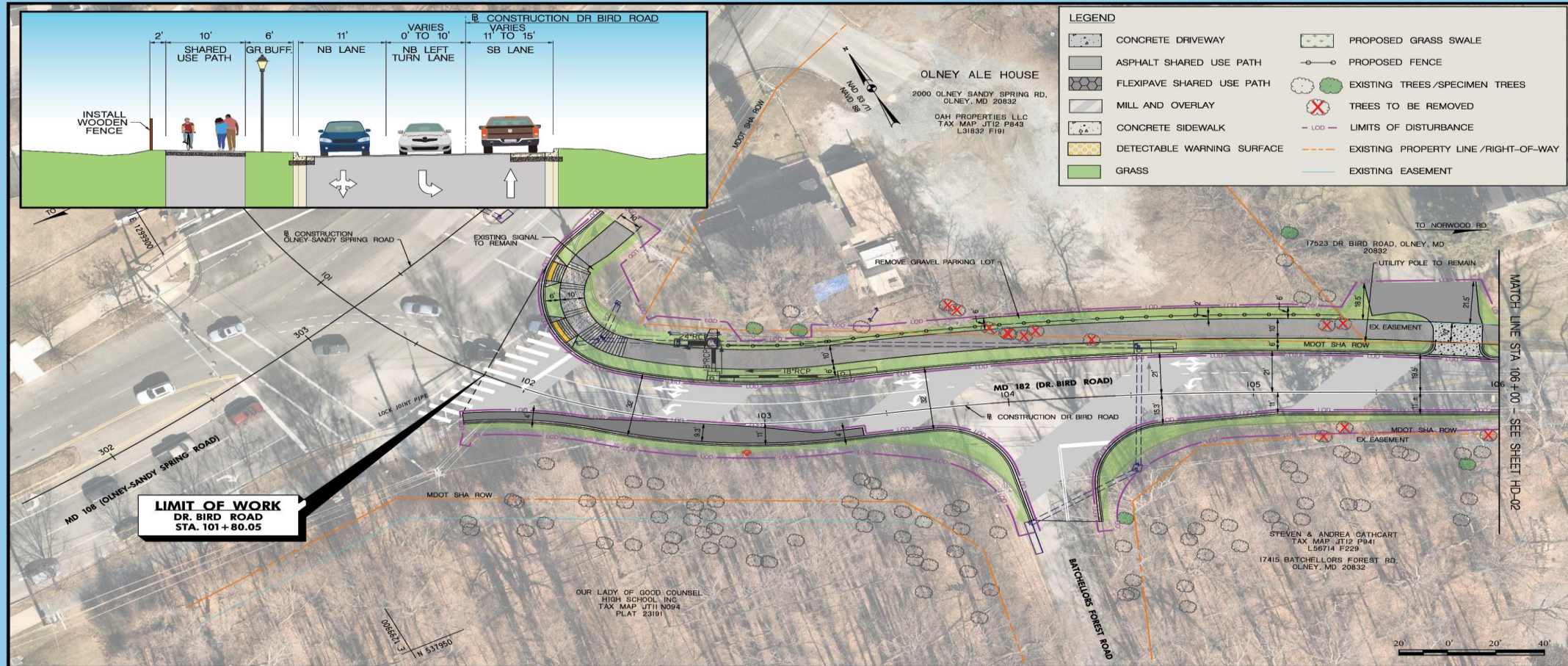
Dr. Bird / Norwood Roads SHARED USE PATH (SUP) DISPLAY A

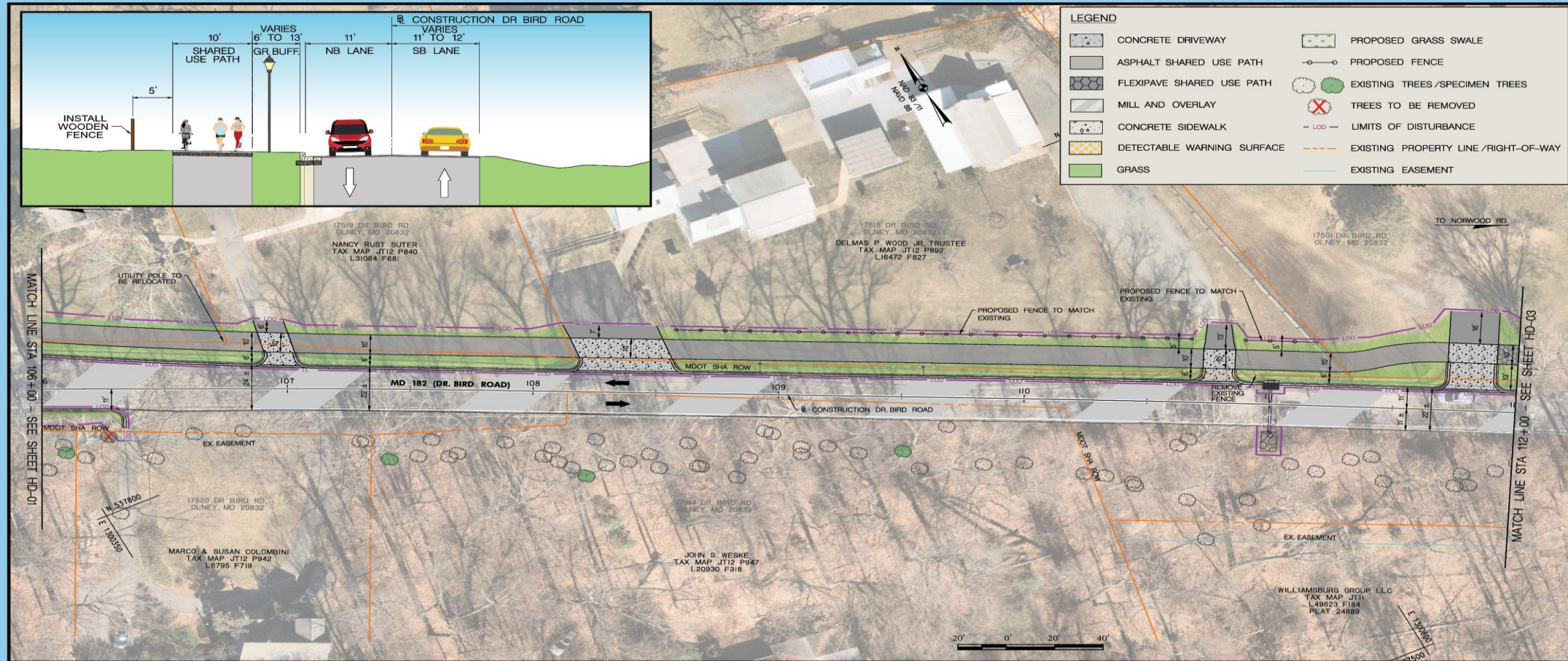

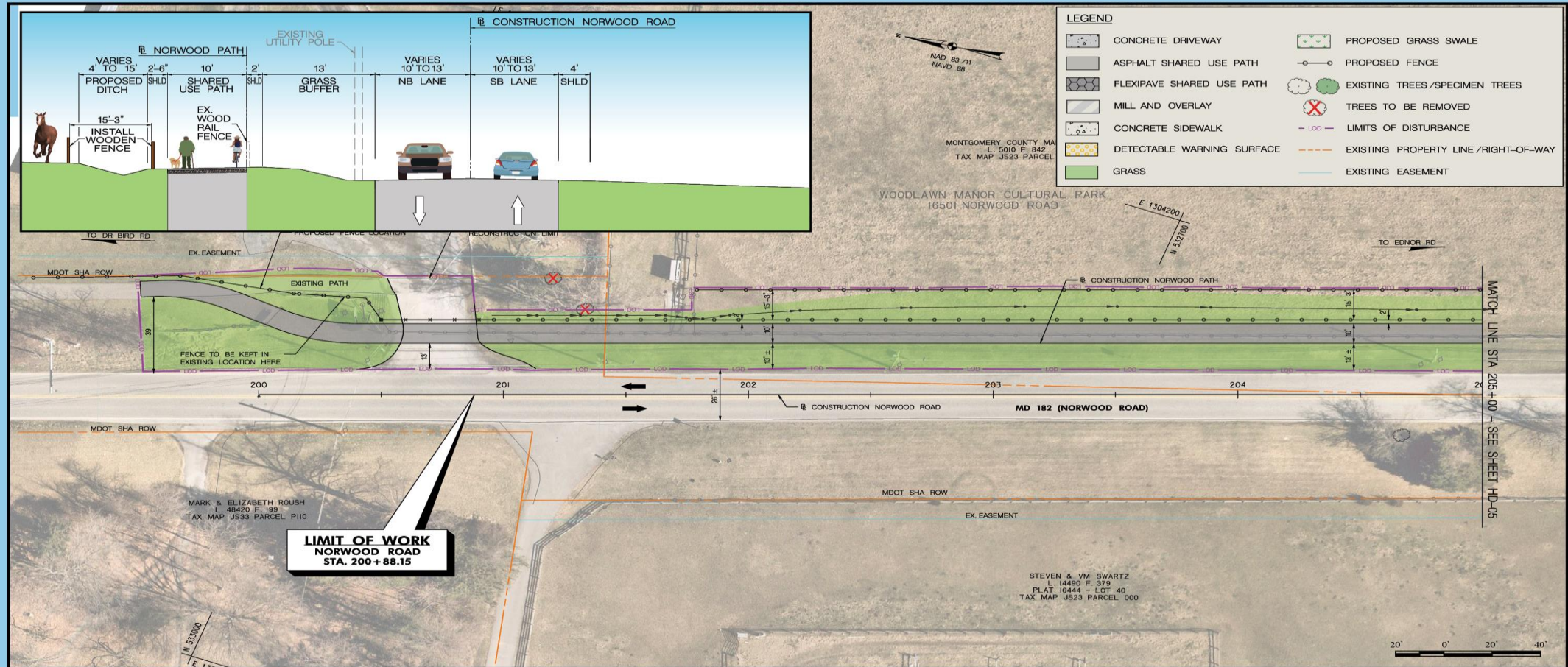

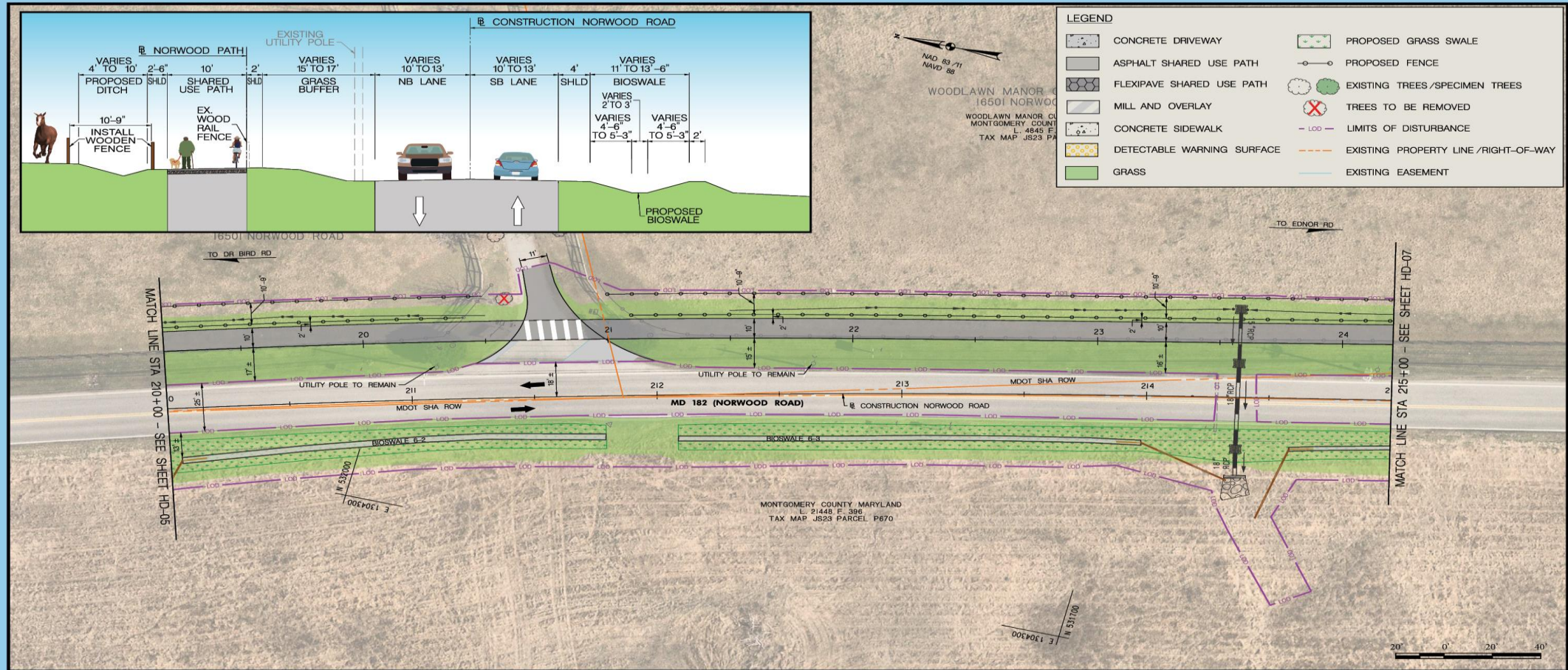

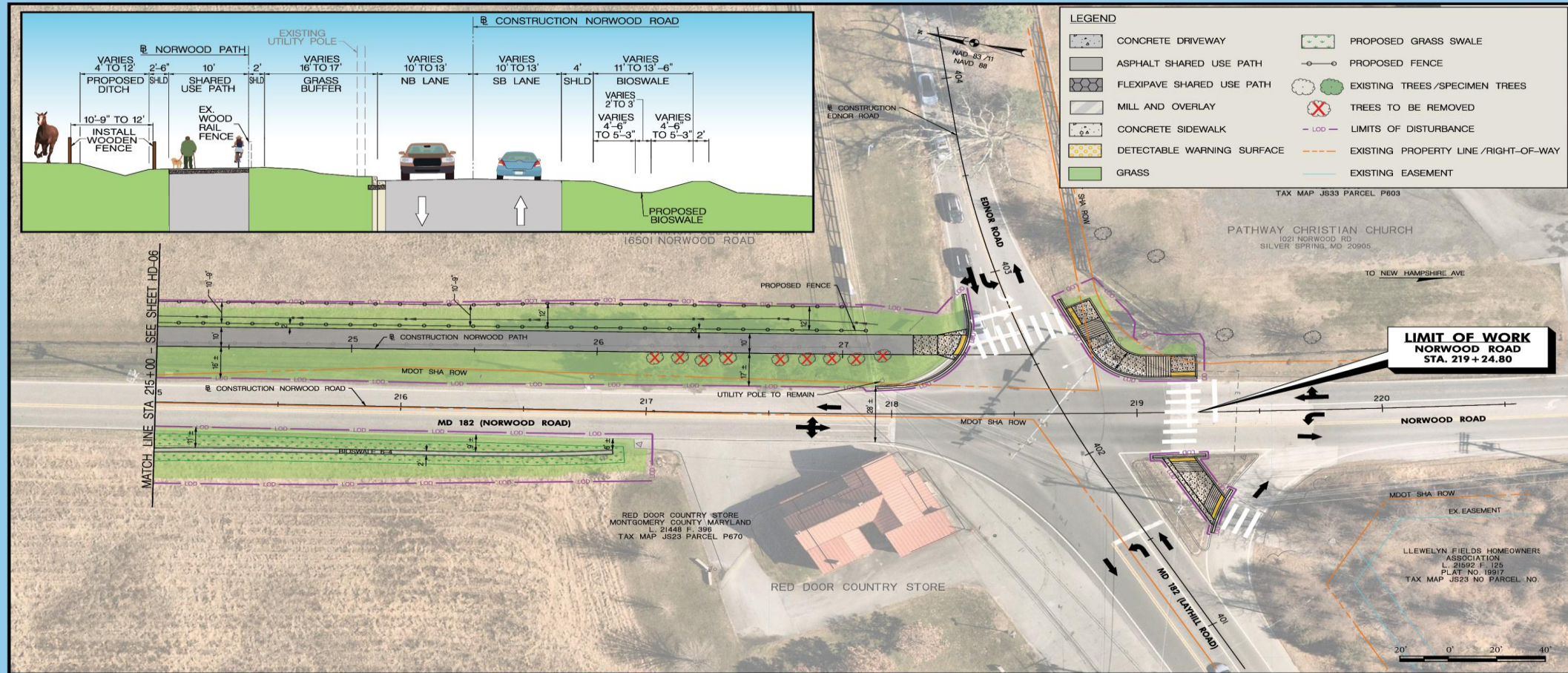
