



# INVITATION TO PUBLIC INFORMATION WORKSHOP TAKOMA-LANGLEY PURPLE LINE STATIONS SIDEWALK PROPOSAL



Montgomery County Department of Transportation (MCDOT) invites you to attend an in-person public workshop to learn more about the Takoma-Langley Purple Line Sidewalk proposal in Silver Spring. The *in-person* meeting will be held on *Thursday, February 27, 2025, at 6:30 p.m., in the All Purpose Room of the Rolling Terrace Elementary School located at 705 Bayfield Street, Takoma Park.* 

#### PROJECT BACKGROUND

The Montgomery County Department of Transportation (MCDOT) has recently completed designs proposing sidewalk connectivity enhancements near the new Purple Line stations to improve pedestrian access and safety in the area. A key component in the County's Climate Action Plan, the new sidewalks will not only provide a safe and convenient pathway for residents to access the stations but will also encourage walking and reduce reliance on cars for transportation.
