

RE: Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Discretionary Grant Program Application - Project Connect: Accelerating Life Science at the North Bethesda Transit-Oriented Development

Dear Secretary Buttigieg:

On behalf of the Montgomery County Department of Transportation (MCDOT), I am pleased to submit this letter as evidence of our commitment of \$21.9 million in local, state, federal, and private funding to *Project Connect: Accelerating Life Science at the North Bethesda Transit Oriented Development*, a \$46.9 million project in partnership with the Maryland Department of Transportation (MDOT) and the Washington Metropolitan Area Transit Authority (Metro).

With a \$25 million FY24 RAISE grant, the North Bethesda Metrorail Station will see a comprehensive suite of investments that facilitate equitable, safer, more direct access to Metrorail and other local destinations. The keystone of this Project is creating a new entrance to the North Bethesda Metrorail Station, which will provide travel time savings and safety benefits for station users.

This project will be executed as a Joint Development, a program authorized by the Federal Transit Administration to create value for transit agencies and local communities. The vision for this 14-acre greenfield site includes a mixed-use high-rise tower above the new entrance to the North Bethesda Metrorail Station, 1,445 residential units, 695,000 sq ft of biotech/healthcare space, and 75,000 sq ft of retail. This Project prioritizes life safety with faster station egress in case of an emergency, contributes to travel time efficiency, strengthens safe, multi-modal connections, accelerates development at the site, and improves transit access for newly developed housing units and retail within a half mile of the Metro station at the Pike and Rose development as well as the planned joint development at the station.

The County and MDOT are committing a mix of local and state dollars, \$21.9 million in nonfederal funds represented in the County's Capital Improvement Plan (CIP) and the Governor's budget:

- County FY24 CIP (P502106) Station Access Improvements
- County FY24 CIP (P502315) Redevelopment Infrastructure
- County FY24 CIP (P501914) North Entrance
- North Entrance State Aid Authorizations/Pre-authorizations

These local sources have either been fully committed through the FY24 County CIP and state authorizations or will be fully committed before a RAISE FY24 grant obligation.

This project represents a critical investment in access to affordable, lower-carbon modes of transportation, travel time savings, life safety, and mobility for thousands of soon-to-be residents and workers traveling through Metro's North Bethesda station.

Thank you for considering the County's request for \$25 million in FY24 RAISE funds for *Project Connect: Accelerating Life Science at the North Bethesda Transit Oriented Development.*
