

Seminary Road Intersection Improvements (CIP Project #501307)

Public Meeting

The Montgomery County Department of Transportation (MCDOT) would like to invite you to a Public Meeting to discuss the Seminary Road project. This will be an informational session where MCDOT staff will provide an overview of the project, the construction process, and the traffic patterns. MCDOT values and seeks your input and feedback during construction and we hope you will join us on March 17 at 7:00 pm at Woodlin Elementary School at 2101 Luzerne Ave, Silver Spring, MD 20910.

Project Description

Located in the Silver Spring area of Montgomery County, Maryland, this project consists of the realignment of a segment of Seminary Road between the Brookeville Road/Seminary Place and Linden Lane/Second Avenue intersections (approximately 400-feet long); Reconstruction of 650-feet of Seminary Place from Seminary Road to 450-feet east of Riley Place, with a vertical alignment revision at Riley Place; Increasing the Linden Lane curb lane widths along the 250-foot section between Brookeville Road and Second Avenue to provide two, 15-foot shared-use lanes.

This project, eliminates the Seminary Road "sweep" between the intersections of Linden Lane/Second Avenue and Brookeville Road . Furthermore, the project provides continuous bike lanes and sidewalks within the project limits and includes a vertical curve reduction on Seminary Place at Riley Place to improve sight distance.
