PROJECT PURPOSE

This project will improve the flow of traffic to and from Briggs Chaney Middle School and improve the roadway network connectivity for residents.

PROJECT SCOPE

The project provides 24-foot wide, two-lane roadway over approximately 300 feet of length by connecting the terminus of Rainbow Drive to Thompson Road. The proposed roadway will be open section with 3-foot wide bio-retention ditches on both sides of the road. The project also includes 4-foot wide concrete sidewalk along the south side of Rainbow Drive and connects to the existing sidewalks at both ends of the proposed sidewalk. There will also be resurfacing work on the existing pavement over approximately 150 feet at the west end of the proposed road, 100 feet at the east end and approximately 75 ft at the north end. The project also adds storm drain structures to the existing storm drain system.

SCHEDULE

Construction duration will be approximately four months and is scheduled to complete by Summer 2011.
