2002 Annual Report

Dear Fellow Citizens:

The following is a report presented to you by the Montgomery County Ethics Commission as required by Chapter 19A-6(f) of the Montgomery County Code. This section requires the Ethics Commission to publish an annual report summarizing the actions it has taken during the preceding calendar year.

In 2002, the Commission held eight meetings to review and consider requests for advisory opinions, waivers, approvals for outside employment and complaints. In May, Walter A. Scheiber's term as Commissioner and Chair ended. Commissioners Elizabeth A. Kellar and Steven Shaw were unanimously elected to serve as Chair and Vice Chair, respectively. The newly vacant Commission position was assumed by Veronique Silverman, upon appointment by the County Executive and confirmation by the County Council.

During the year, the Commission issued 12 advisory opinions and granted 1 waiver (see the Commission's website under "Opinions and Waivers"); processed 4 complaints; reviewed and decided 701 requests for outside employment approval (see Appendix A below); processed registrations from 88 lobbyists (on behalf of 52 parties) and reviewed and reported on 133 lobbyist reports (see Appendix B below); and processed 1255 financial disclosure statements.

To improve access to Ethics Commission information, the Commission added more content to the web site (www.montgomerycountymd.gov/ethics). Annual Reports for the last four years are now posted. Advisory Opinions and Waivers from this year are now posted as individual .pdf files, together with relevant recent County Attorney's opinions; it is intended in the near future to post on the website indexed files of all Advisory Opinions and all Waivers since 1990. Electronic filing of financial disclosure statements (inaugurated this year for the 2001 reporting year) continued, with 79% of filers choosing to file electronically. It is intended that paper filing will be phased out in 2004 for the 2003 reporting year, in order to improve tracking of these submissions.

As always, the Commission seeks opportunities to promote high ethical standards and to respond to issues that concern citizens.
