2003 Annual Report

Dear Fellow Citizens:

The Montgomery County Ethics Commission presents the following report to you as required by Chapter 19A-6(f) of the Montgomery County Code. This section requires the Ethics Commission to publish an annual report summarizing the actions it has taken during the preceding calendar year.

In 2003, the Commission held nine meetings to review and consider requests for advisory opinions, waivers, approvals for outside employment, and complaints. In April, Commissioner Kellar was reelected as Chair, and Commissioner Reback was installed as Vice Chair.


During the year, the Commission issued 16 advisory opinions; granted 2 waivers; processed 9 complaints; reviewed and decided 636 requests for outside employment approval (see Appendix A); processed registrations from 84 lobbyists (on behalf of 67 parties) and reviewed and reported on 77 lobbyist reports (see Appendix B); and processed 1443 financial disclosure statements.

One of the Commission's Advisory Opinions relating to the prestige of office for private gain drew widespread public attention. It concerned a public employee's request for permission to engage in secondary employment to write a book and consult on a movie. While the book was described as a memoir, the employee acknowledged that it would include the employee's description of events related to his experience in a high profile police matter that drew worldwide attention. Sections 19A-14 and 19A-15 of the County Ethics Law were implicated. Two Commission decisions of immediate relevance to this case, 02-011 (on honoraria) and 03-011 (on prestige of office), are posted along with two other pertinent documents on the Commission's website (links "Opinions and Waivers" and "Advisory Opinions 2002-present").

To improve access to Ethics Commission information, the Commission added more content to the web site (www.montgomerycountymd.gov/ethics). Annual Reports for the last five years are now posted, as well as indexed files of all Advisory Opinions and all Waivers from 1990 through 2001. Advisory Opinions and Waivers from 2002 and 2003 are now posted as individual pdf files, together with relevant recent County Attorney's opinions. Electronic filing of financial disclosure statements (inaugurated in 2002 for the 2001 reporting year) continued, with 86% of filers choosing to file electronically.

As always, the Commission seeks opportunities to promote high ethical standards and to respond to issues that concern citizens.
