2005 Annual Report

Dear Fellow Citizens:

The Montgomery County Ethics Commission presents the following report to you as prescribed by Chapter 19A-6(f) of the Montgomery County Code. This section requires the Ethics Commission to publish an annual report summarizing the actions it has taken during the preceding calendar year.

For the Commission, 2005 has been a year of membership changes. In February, Mr. Antar Johnson was appointed to fill the vacancy left by the resignation of Commissioner Steven Shaw the previous year, and in December Ms. Nina Weisbroth and Mr. Stuart Rick were appointed to fill vacancies left by the expiration of Commissioner Elizabeth Kellar's term and the resignation of Commissioner Veronique Silverman. A vacancy still remains due to the resignation of Commissioner Jerome Joseph.

On June 14, the Commission held its annual election of officers electing Richard Reback as Chair. It was decided at that time that the members would not vote on a Vice Chair until the Commission was at full complement.

In 2005, the Commission held six meetings: January 11, February 8, April 19, June 14, October 18, and November 9 to review and consider requests for legislative changes, advisory opinions, waivers, complaints, and approvals for outside employment requests. During the year the Commission issued 3 advisory opinions, granted 5 of 6 waivers requested, issued 1 consent order, processed 3 complaints of which 1 required assistance from the County Attorney's Office, reviewed and decided 724 outside employment requests for approval (Appendix A below), processed registrations from 118 lobbyists and reviewed and reported on 154 lobbyist reports (See Appendix B below), and processed 1674 financial disclosures.

As in the year prior, the Commission was invited by the Chief Administrative Officer to participate in a Management Leadership Forum on ethics. Several members attended and addressed the

audience of senior and mid-level County managers regarding ethics topics. The meeting was an opportunity to reinforce the administration's efforts to provide transparent government to the public through the instruments developed by the Commission such as financial disclosure and the outside employment program.

As pertains to the financial disclosure program, a survey was conducted to determine how well the electronic system is being embraced. There was a 95% satisfaction rate. This can be attributed to the Commission's strong effort to provide a sound interactive program which has won national acclaim as well as adding a customer service position to assist filers. To insure that filings are made as required by law, the Chief Administrative Officer authorized the Executive Secretary of the Commission to issue citations which carry fines to delinquents. The Commission experienced a 99.9% compliance rate for the filing period.

The Commission continues to seek opportunities to promote high ethical standards and to respond to issues that concern citizens. All Commission decisions are published with this document. Please let us know how the Commission can serve you.
