## 2006 Annual Report

Dear Fellow Citizens:

The Montgomery County Ethics Commission presents the following annual report as required by Chapter 19A-6(f) of the Montgomery County Code summarizing its actions during the preceding calendar year.

For 2006, Commission membership remained unchanged. Richard N. Reback retained his chairmanship with the full support of Commissioners Antar Johnson, Stuart Rick, and Nina Weisbroth. There is currently one vacancy.

This past year, the Commission held six meetings to review and consider requests for advisory opinions, waivers, complaints, and outside employment. As a result, the Commission issued 7 advisory opinions, resolved 6 complaints, and approved 981 outside employment requests, denying 3 (Appendix A). Additionally, the Commission has been working on legislative amendments to the ethics law, which will be presented to the Executive and Council in 2007.

Commission staff processed 220 lobbyist registrations and 248 lobbyist reports (See Appendix B), and 1844 financial disclosures.

To make Commission information more readily available, all opinions, waivers, and lobbyist registrations are published online as they are completed or received. In the coming year, it is anticipated that outside employment approvals will be posted on a monthly schedule. Additional training materials will also be added to the website.

The Commission continues to seek opportunities to promote high ethical standards and to respond to issues that concern citizens. Please let us know how the Commission can serve you.
