2007 Annual Report

Dear Fellow Citizens:

The Montgomery County Ethics Commission presents the following annual report as required by Chapter 19A-6(f) of the Montgomery County Code summarizing its actions during the preceding calendar year.

2007 brought change to the Commission membership. Chairman Richard Reback, having served two terms, was retired as a member. Commissioner Antar Johnson succeeded Mr. Reback as Chairman and two new members, Gilles Burger and Raphael Borrás, were appointed.

This past year, the Commission held seven meetings to review and consider requests for advisory opinions, waivers, complaints, and outside employment. As a result, the Commission issued 9 advisory opinions, 1 waiver, resolved 6 complaints, and approved 1051 outside employment requests, denying 3 (Appendix A). Additionally, the Commission prepared legislative amendments to the ethics law, which will be presented to the Executive and Council in 2008.

Commission staff processed 362 lobbyist registrations and 136 lobbyist reports (See Appendix B), and 1930 financial disclosures.

To make Commission information more readily available, all opinions, waivers, and lobbyist registrations are published online as they are completed or received. In 2007, outside employment approvals were posted on a monthly schedule. Additional training materials were also to be added to the website.

The Commission continues to seek opportunities to promote high ethical standards and to respond to issues that concern citizens. Please let us know how the Commission can serve you.
