In Bethesda: for northbound traffic on Allan Terrace at Baltimore Avenue.

REMOVE: (T.O. 2-09, 8a)
No Parking Any Time

In Bethesda: on the south side of Allan Terrace from 100' west of Glen Cove Parkway to Glen Cove Parkway.

REMOVE: (T.O. 2-09, 9a)
No Parking Any Time

In Bethesda: on the north side of Allan Terrace from Glen Cove Parkway (road end) to 100' west of Glen Cove Parkway (road end).

REMOVE: (T.O. 59-12, 1a)
No Parking Any Time

In Bethesda: on the east side of Glen Cove Parkway from Baltimore Avenue to the north side of Allan Terrace.

REMOVE: (T.O. 59-12, 2a)
No Parking Any Time

In Bethesda: on the west side of Glen Cove Parkway from Allan Terrace to 50' south of Allan Terrace.

2a INSTALL:

In Bethesda: on the east side of Glen Cove Parkway from the southern curb face of Newport Avenue to 130 feet south of the northern curb face of Allan Terrace.

3a INSTALL:
No Stopping Any Time

In Bethesda: on the east side of Glen Cove Parkway from 130 feet south of the northern curb face of Allan Terrace to the northern curb face of Allan Terrace.

4a INSTALL:
No Stopping Any Time

In Bethesda: on the north side of Allan Terrace from the eastern curb face of Glen Cove Parkway to 110 feet west of the eastern curb face of Glen Cove Parkway.

5a INSTALL:
No Parking Any Time

In Bethesda: on the south side of Allan Terrace from 80 feet west of Glen Cove Parkway to Glen Cove Parkway.

6a INSTALL:
No Parking Any Time

In Bethesda: on the west side of Glen Cove Parkway from Allan Terrace to 50 feet south of Allan Terrace.
