BACKGROUND INFORMATION: On October 2, 2018, by Resolution No. 18-1243, the Montgomery County Council adopted Executive Regulation 8-18, Schedule of Fees for Fire Safety Permits, Code Modifications, Inspections, and Licenses (referred to as the Fire Code Compliance Fee regulation or "FCC fee regulation"). The originating department, however, intended a 90-days post adoption implementation in order to accommodate administrative and technology changes to implement the revised fees.

For the foregoing reasons, the Executive finds that a public or fiscal emergency requires the adoption of this temporary regulation and the public interest will be materially harmed if the regulation does not take effect immediately.

COMCOR No. 22.00.03 SCHEDULE OF FEES FOR FIRE SAFETY CODE PERMITS, CODE MODIFICATIONS, INSPECTIONS and LICENSES

Sec. 1. Statement of Purpose.

This temporary executive regulation corrects a technical problem with the intended effective date of Executive Regulation 8-18 to assure that fees collected are consistent with effective regulations. To prevent material harm to the public interest the effective date of Executive Regulation 8-18 is retroactively suspended from October 2, 2018 through January 1, 2019 and does not supersede Executive Regulation 12-12 through January 1, 2019. Executive Regulation 8-18, which was adopted by Council Resolution No. 18-1243, will take effect beginning on January 2, 2019 without further amendment or alteration.

Sec. 2. General Provisions.

- A. The implementation of Executive Regulation 8-18 is temporarily suspended from the date of adoption by Council Resolution 18-1243 through January 1, 2019.
- B. Executive Regulation 12-12 remains effective during the period that Executive Regulation 8-18 is temporarily suspended.
- C. Executive Regulation 8-18 is effective, without amendment or alteration, on January 2, 2019.
