1. Pursuant to Section 49-54 of the Montgomery County Code (2004) as amended, the County Executive hereby finds that public interest requires construction of a sidewalk to provide safe pedestrian travel along the east side of Debroah Drive from Bells Mill Road to Democracy Lane, located in Potomac, Maryland within Election District 10. The Director of the Department of Transportation is hereby authorized to proceed with construction of a concrete sidewalk under Capital Improvement Project No. 0506747 (Annual Sidewalk Program).

The sidewalk will be five feet wide and will conform to ADA requirements. The total length of the sidewalk is approximately 570 linear feet. Deborah Drive is classified as a residential roadway and has a 70 foot wide public right-of-way. The existing roadway is approximately 24 feet wide, with approximately 23 feet of available public right-of-way on the north side of Gold Mine Road. There will be a three foot wide greenspace located between the new sidewalk and edge of roadway. Every effort will be made throughout the construction phase to cause minimal disturbance within the public right-of-way and to the adjacent properties.

A Public Hearing was conducted on the project at 6:00 p.m. on Wednesday, February 6, 2013, in the Lobby Level Auditorium of the Executive Office Building (COB) located at 101 Monroe Street, in Rockville, Maryland. The Hearing Examiner recommended approval of the project.

2. The County Executive hereby proposes that the total cost of the project, to be determined by a final accounting after construction has been completed, shall be distributed in the approximate amounts as follows:

\$ 25,603.00	Construction Costs, G.O. Bonds
\$ N/A	Costs to be assessed for special benefit against applicable properties
\$ 2,560.00	Administrative and Construction Inspection Costs, G.O. Bonds
\$ 28,163.00	Total estimated cost of the project. Including engineering, site improvements and construction

3. Unless otherwise approved by the County, expenditures authorized by this Order plus expenditures accrued to date for this project shall not exceed \$28,163.00 and shall be made payable from funds appropriated for CIP No. 0506747.




