1. Pursuant to Section 49-53 of the Montgomery County Code (2004) as amended, public hearings for construction of sidewalks shall be held before the County Executive (or his designee) on Wednesday, October 2, 2013, in the First Floor Auditorium of the Executive Office Building (EOB) located at 101 Monroe Street, Rockville, Maryland. The scheduled hearings will begin at 6:00 p.m. and continue consecutively thereafter. The purpose for this hearing is to consider a proposal to provide safer pedestrian travel along multiple roadways within the Glenmont Forest Community, located in Silver Spring, Maryland within Election District 13. All of the following sidewalks will be constructed under Capital Improvement Project No. 0506747 (Annual Sidewalk Program) and will conform to the Americans with Disabilities Act (ADA) requirements.

**A. Lindell Street: *South Side*** – (*Randolph Road to Georgia Avenue/MD97*)

Lindell Street is classified as a residential roadway with a 60 foot wide public right-of-way. The existing pavement width is approximately 36 feet wide and there is approximately 12 feet of available public right-of-way on the south side of Lindell Street. The total length of the proposed sidewalk is approximately 3,740 feet.

## **B. Grandview Avenue: *East Side* – (Mason Street to Weisman Road)**

Grandview Avenue is classified as a residential roadway with a 60 foot wide public right-of-way. The existing pavement width is approximately 36 feet wide and there is approximately 12 feet of available public right-of-way on the east side of Grandview Avenue. The total length of the proposed sidewalk is approximately 900 feet.

## **C. Munson Street: *North Side* – (Kendall Street to Judson Road)**

Munson Street is classified as a residential roadway with a 50 foot wide public right-of-way. The existing pavement width is approximately 26 feet wide and there is approximately 12 feet of available public right-of-way on the north side of Munson Street. The total length of the proposed sidewalk is approximately 1,900 feet.

**D. Weisman Road: *South Side*** – (*Judson Road to Georgia Avenue/MD97*)

Weisman Road is classified as a residential roadway with a 50 foot wide public right-of-way. The existing pavement width is approximately 26 feet wide and there is approximately 12 feet of available public right-of-way on the south side of Weisman Road. The total length of the proposed sidewalk is approximately 1,480 feet.

2. Unless otherwise approved by the County, expenditures authorized by this Order, plus expenditures accrued to date for the construction of above listed proposed sidewalks shall not exceed \$534,210.00 and shall be made payable from funds appropriated for CIP Project #0506747.
3. Every effort will be made throughout the entire construction phase to cause minimal disturbance within the public right-of-way and to all properties adjacent to the proposed sidewalk construction sites.
4. Project related data and files are available for examination in the offices of the Department of Transportation, 100 Edison Park Drive, Gaithersburg, Maryland 20878.
5. The sole purpose of this hearing is to obtain public comments to assist the County Executive in determining whether or not to authorize construction of the entire project as proposed, or any portions thereof.


