1. Pursuant to Section 49-53 of the Montgomery County Code (2004) as amended, public hearings for construction of proposed sidewalks shall be held before the County Executive (or his designee) on Wednesday, October 2, 2013, in the First Floor Auditorium of the Executive Office Building (EOB) located at 101 Monroe Street, Rockville, Maryland. The scheduled hearings will begin at 6:00 p.m. and continue consecutively thereafter. The purpose for this hearing is to consider safer pedestrian travel along the south side of Luzerne Avenue from 9120 Glenridge Avenue to Louis Avenue, located in Silver Spring, Maryland within Election District 13 by constructing:

A new concrete sidewalk under Capital Improvement Project #506747 (Annual Sidewalk Program). The sidewalk will be five feet wide and will conform to the Americans with Disabilities Act (ADA) requirements. The total length of the sidewalk is approximately 200 linear feet. Luzerne Avenue is classified as a residential roadway and has a 50 foot wide public right-of-way. The existing roadway is approximately 23 feet wide and there is approximately 13 feet of available public right-of-way on the south side of Luzerne Avenue. There will be a variable width greenspace located between the new sidewalk and edge of the roadway. Every effort will be made during construction to cause minimal disturbance within the public right-of-way and to the adjacent properties.

2. Estimated cost of the proposed improvement and funding allocations thereof are as follows:

\$	21,814.00	Construction Costs, G.O. Bonds
\$	N/A	Costs to be assessed for special benefit against applicable properties
\$	2,181.00	Administrative and Construction Inspection Costs, G.O. Bonds
\$	23,995.00	Total estimated cost of the project. Including engineering, site improvements and construction

4. The sole purpose of this hearing is to obtain public comments to assist the County Executive in determining whether or not to authorize construction of the entire project as proposed, or any portions thereof.






