Section 11B.00.01.02 Definitions is amended as follows:

* * *

2.4.72 Principal Place of Business in the County: [A regular course of business commerce in the County by a business, along with any of the following:] A Business, which is not certified as a local business in any other jurisdiction, and which:

- (1) [The business has] <u>Has</u> its physical business location(s) only in the County; or
- (2) [The business has] <u>Has</u> physical business locations both in and outside of the County, and:

 (a) the County-based location(s) account for over 50% of the business's total number of employees[,]; or
 - (b) the County-based location(s) account for over 50% of the business's gross sales[.]; or
 - (c) all of the business' high-level officers are based in the business' County-based location(s) for the purpose of directing, controlling, and coordinating the business' activities. A business' high-level officers include each of the following roles or its equivalent: Chief Executive Officer (CEO); Chief Financial Officer (CFO); Chief Operating Officer (COO); Chief Technology Officer (CTO)/Chief Information Officer (CIO); and Chief Human Resources Officer (CHRO).
