Boneset Way North: Starting approximately 745 feet west of the intersection of Ridge Road, (Maryland Rte. 27), beginning at Station 0+00.00 as a tertiary closed section residential roadway (MCDOT Std. 2001.01) with a right of way 44 feet, transitioning to a 60 foot right of way at Station 6+53.17 ending at Station 7+30.93 with paving 28 feet wide, and continuing in a northeasterly direction terminating in a cul de sac. Paving 20 feet wide, with five (5') foot wide concrete sidewalk on the both sides ending at station 7+60 all within the dedicated right of way, curb and gutter, storm drainage, with a 3-inch asphaltic concrete base course, a 1.5-inch asphaltic concrete intermediate, and a 1.5-inch asphaltic concrete surface course.

Boneset Way South: Starting approximately 745 feet west of the intersection of Ridge Road, (Maryland Rte. 27), beginning at Station 0+00.00 as a tertiary closed section residential roadway (MCDOT Std. 2001.01) with a right of way 44 feet in width and transitioning to a 60 foot right of way from Station 4+31.04 to Station 4+99.00 with 28 feet of paving, continuing in a southerly direction intersecting with Butterfly Weed Drive at Station 9+05.00 and Mountain Mist Drive at Station 18+55 terminating in a cul de sac at Station 25+28.91 for a total distance of 2528.91 feet. Paving 20 feet wide, with five (5') foot wide concrete sidewalk on both sides ending at Station 22+14 on the west side and Station 23+15 on the east side all within the dedicated right of way. Curb and gutter, storm drainage, with a 3-inch asphaltic concrete base course, a 1.5-inch asphaltic concrete intermediate, and a 1.5-inch asphaltic concrete surface course.

<u>Butterfly Weed Drive:</u> Starting at the intersection of Mountain Mist Drive at Station 0+00 as a tertiary closed section residential roadway (MCDOT Std. 2001.01) with a right of way 44 feet in width and continuing in a northerly direction intersecting with Boneset Way South at Station 10+00.00 and terminating in a cul de sac at Station 17+35.86 for a total distance of 1735.86 feet. Paving 20 feet wide, with five (5') foot wide concrete sidewalk on the both sides terminating at

Station 15+16 on the northeast side and Station 16+65 on the northwest side all within the dedicated right of way, curb and gutter, storm drainage, with a 3-inch asphaltic concrete base course, a 1.5-inch asphaltic concrete intermediate, and a 1.5-inch asphaltic concrete surface course.

Mountain Mist Drive: Starting at the intersection with Brink Road (Station 6+65), 665 feet south of Ridge Road (Maryland Rte. 27) at Station 0+58.92 as a tertiary closed section residential roadway (MCDOT Std. 2001.01) with a right of way 44 feet in width and continuing in a northeasterly direction transiting to a 50 foot right of way at Station 7+09.38 (Paving width is 28 feet from Station7+09.38 to Station 8+13.09) to the intersection of Butterfly Weed Drive. Paving 20 feet wide, with five (5') foot wide concrete sidewalk on the east side only until Station 4+65 and continuing both sides until intersecting with Boneset Way South, all within the dedicated right of way. Beginning at Station 6+35 as a tertiary closed section residential roadway (MCDOT Std.2001.02) with a right of way 50 feet in width and continuing in an easterly direction ending at the intersection of Boneset Way South at Station 8+87.24 for a total distance of 887.24 feet. Paving width varies from 20 feet to 28 feet. Five (5') foot wide concrete sidewalks on both sides and within the dedicated right of way, curb and gutter, storm drainage with a with a 3-inch asphaltic concrete base course, a 1.5-inch asphaltic concrete intermediate, and a 1.5-inch asphaltic concrete surface course.
