2a	<u>INSTALL:</u> Permit Parking Only Henderson	<u>In Wheaton/Glenmont:</u> on the south side of Lindell Street from 70 feet east of Grandview Avenue to 55 feet west of Georgia Avenue (MD 97).
3a	<u>INSTALL:</u> No Parking Any Time	<u>In Wheaton/Glenmont:</u> on the south side of Lindell Street from 55 feet west of Georgia Avenue (MD 97) to Georgia Avenue (MD 97).
4a	<u>INSTALL:</u> Permit Parking Only Henderson	<u>In Wheaton/Glenmont:</u> on the north side of Lindell Street from 35 feet west of Georgia Avenue (MD 97) to 215 feet west of Georgia Avenue (MD 97).
5a	<u>INSTALL:</u> No Parking Any Time	<u>In Wheaton/Glenmont:</u> on the north side of Lindell Street from 215 feet west of Georgia Avenue (MD 97) to 245 feet west of Georgia Avenue (MD 97).
