Coolidge Avenue: A closed section residential roadway with a varying width right of way beginning at existing pavement at Station 9+07.03 at the intersection with Hoyle House Way (private) and continuing in a northerly/southerly direction ending at Station 32+93.34 just prior to Norbeck Road (Maryland Rte. 28). The right of way varies from 50 feet in width at Station 9+07.03 transiting to 44 feet in width at Station 12+67.08 and continuing to Station 16+87.75 (MCDOT Std. 2001.02), transitioning to a 50 foot right of way at Station 16+87.75 to 21+48.71 (MDCOT Std. 2002.01) transitioning to a 60-foot wide right of way beginning at Station 21+48.71 ending at Station 30+81.16 (MCDOT Std. 2002.01) transitioning to a 70 foot wide right of way beginning at Station 30+81.16 to Station 32+93.34 (MCDOT Std 2003.11).

Paving width varies starting at 28 feet in width at Station 9+07.03 transitioning to 20 feet in width at Station 11+10.00 continuing to Station 17+37.82, transitioning to 21.5 feet in width at Station 19+75.82 to Station 22+94.47 transitioning to 36 feet in width at Station 23+04.96 to Station 32+93.34.

Coolidge Avenue intersects Hoyle House Way (private) at Station 9+07.03, Landing Way (private) at Station 10+08.00 and again at Station 22+50.71, Summer House Drive (private) at Station 11+43.99, Bradford Road at Station 16+94.29, Doc Berlin Drive at Station 24+85.71 and Clara Downey Avenue at Station 29+00.85.

Concrete sidewalk, 5 foot in width on both sides beginning at Station 9+07.03 and within the County right of way transitioning to an eight (8') foot asphaltic concrete shared use path on the <u>north side only</u> beginning at Station 16+85 and ending at approximate Station 20+85.00 adjacent to lot 23, block A, transitioning to concrete sidewalk, 5 foot in width and within the dedicated right of way to Station 32+93.34. Eight (8') foot asphaltic concrete shared used path on <u>west side only</u> beginning at Station 21+79.77 and continuing to Station 32+93.34 and within the dedicated right of way. Curb and gutter, with a 5-inch asphaltic concrete base course, and a 1.5-inch asphaltic concrete intermediate course and a 1.5-inch asphaltic concrete surface course. For a total distance of 2386.31 feet.

<u>Bradford Road:</u> A closed section modified tertiary residential roadway (MCDOT Std. 2001.02) with a right of way 50 feet in width beginning at Station 0+00 at the intersection with Clara Downey Way and continuing in a northerly direction transitioning to a 44-foot wide right of way at Station 2+89.14, intersecting with Doc Berlin Drive at Station 4+15.14 and Landing Way (private) at Station 6+50.14, ending at Station 8+52.14 at the intersection of Coolidge Avenue.

Paving 28 feet in width from Station 0+00 to Station 2+67.89 transitioning to 20 feet in width at Station 2+79.09 to Station 8+52.14. Concrete sidewalk five (5') foot in width on the west side only and within the dedicated right of way. Asphaltic concrete shared use path eight (8') feet in width on the east side only and within the dedicated right of way. Curb and gutter, with a 3-inch asphaltic concrete base course, a 1.5-inch asphaltic concrete intermediate course and a 1.5-inch asphaltic concrete surface course. <u>Doc Berlin Drive:</u> A closed section tertiary residential roadway (MCDOT 2001.02) with a right of way 50 feet in width beginning at Station 15+39.44 at existing pavement and continuing in an easterly direction intersecting Bradford Road at Station 15+95.80, Steamboat Way (private) at Station 16+98.00, Trolley Way (private) at Station 18+80 ending at Station 19+93.15 at the intersection of Coolidge Avenue.

Paving 20 feet in width, concrete sidewalks on both sides, five (5') feet in width and within the dedicated right of way. Curb and gutter, with a 3-inch asphaltic concrete base course, a 1.5" asphaltic concrete intermediate course and a 1.5" asphaltic concrete surface course. For a total distance of 453.71 feet.

Paving 20 feet in width beginning at Station 15+70.40 to to Station 21+79.77. Concrete sidewalk five (5') foot in width on the north side only and within the dedicated right of way. Eight foot (8') asphaltic concrete shared use path on the south side only and within the dedicated right of way.
