Pursuant to Section 31-2 and 31-10, Montgomery County Code, 2004, as amended, you are hereby directed to install and/or remove the following traffic and/or parking control devices at the designated location(s).

REMOVE: (T.O. 131-02, 4a)  
No Parking Any Time

In Bethesda: on the west side of Sangamore Road from 350' south of Overlea Road to 560' north of Brookes Lane/Entrance-Exit driveway to National Imagery and Mapping Agency.

REMOVE: (T.O. 131-02, 5a)  
No Standing Any Time

In Bethesda: on the west side of Sangamore Road from 560' north of Brookes Lane/Entrance-Exit driveway to National Imagery and Mapping Agency to the driveway to National Imagery and Mapping Agency /Brookes Lane.

REMOVE: (T.O. 109-04, 2a)  
No Parking Any Time

In Bethesda: on the west side of Sangamore Road from the extended southern curblineline of Overlea Road to the extended southern curblineline of Sentinel Drive.

REMOVE: (T.O. 109-04, 3a)  
No Standing Any Time

In Bethesda: on the west side of Sangamore Road from the extended southern curblineline of Sentinel Drive to Brookes Lane.

1a    INSTALL:  
No Parking Any Time

In Bethesda: on the west side of Sangamore Road from the extended southern curblineline of Overlea Road (southern intersection) to 120 feet south of the middle driveway to 4600 Sangamore Road.

2a    INSTALL:  
No Parking Any Time

In Bethesda: on the west side of Sangamore Road from 55 feet north of the southern most driveway to 4600 Sangamore Road to the southern most driveway to 4600 Sangamore Road.
