Notice of Proposed Disposition Through Sale – Approximately 7,100 Square Feet of County Property

In accordance with Section 11B.45.01 *et seq.* of the Code of Montgomery County Regulations, Montgomery County, Maryland, announces that it proposes to sell approximately 7,100 square feet of property located in Germantown. The property is included in a nearly ten-acre site at the southeastern quadrant of the intersection of Clopper Road/MD 117 and Germantown Road/MD 118 in Germantown. The approximately 7,100 square foot property consists of three components that were transferred to the County in 1997 and 1999 for the relocation of MD 118, as recorded among the Land Records of Montgomery County at Book 15709, Page 104; Book 14761, Page 1; and Book 17807, Page 92.

In July 2023, the Montgomery County Planning Board approved a Preliminary Plan and Site Plan for the nearly ten-acre site, to create 61 lots for townhouses, including 12.5 percent Moderately Priced Dwelling Units, and two lots for up to 12,000 square feet of retail/service. The Developer, Kingsview Station Joint Venture, will dedicate approximately 31,500 square feet of additional right-of-way to the County for the reconstructed Liberty Mill Road, and the County will dispose of the approximately 7,100 square foot property. The Developer will fully construct and dedicate to public use the right-of-way for the realignment of Liberty Mill Road connecting Clopper Mill Road and Leaman Farm Road as recommended in the 1989 Germantown Master Plan. The County proposes selling the property to the Developer for a nominal purchase price of \$10.

A virtual public hearing on the proposed sale of property will be held at 1:30 pm on January 3, 2024 via a Zoom meeting. Information on how to attend can be found at: https://montgomerycountymd.gov/DGS/OPD/home.html.
