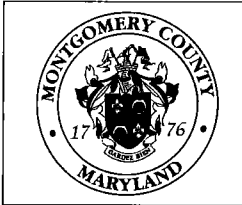

Castle Oak Road: A modified secondary residential road with a right-of-way 60 feet wide starting at Station 0+00 at the intersection with Snowden Farm Parkway (Station 26+16.76) to Station 12+18.68 terminating at existing pavement. A distance of 1,219 feet, pavement 20 feet wide (open section) with curbs and gutters at intersections only, and sidewalk(s) 5 feet wide on both sides. Sidewalks are located within public improvements easements. Pavement consists of a 3-inch asphaltic concrete base course, 1.5 asphaltic concrete intermediate course and a 1.5 asphaltic concrete surface course.

A distance of 773 feet, with a varying pavement width of 52 feet to 64 feet (open section), with sidewalks right side only, a bikeway left side only, curbs and gutters, around

A distance of 135 feet, with a pavement width of 62 feet, with curbs and gutters, around median, storm drainage, and sidewalks right side only, a bikeway left side only both within public improvements easements, with pavement consisting of an 8-inch aggregate base course, 5-inch asphaltic concrete base course, 1.5-inch asphaltic concrete intermediate course, and a 1.5-inch asphaltic concrete surface course.
