	<u>REMOVE:</u> (T.O. 107-02, 7a) No Stopping Any Time	<u>In Wheaton/Glenmont:</u> on both sides of Plyers Mill Road from 50' west of Maybrook Avenue to 50' east of Maybrook Avenue.
	<u>REMOVE:</u> (T.O. 107-02, 8a) No Stopping School Days 8AM - 4PM	<u>In Wheaton/Glenmont:</u> on the south side of Plyers Mill Road from 50' east of Maybrook Avenue to 370' east of Maybrook Avenue.
1a	<u>INSTALL:</u> No Parking School Days 8AM - 4PM	<u>In Silver Spring:</u> on the south side of Plyers Mill Road from 300 feet west of the extended western curb line of Maybrook Avenue to 50 feet west of the extended western curb line of Maybrook Avenue.
2a	<u>INSTALL:</u> No Stopping Any Time	<u>In Silver Spring:</u> on the south side of Plyers Mill Road from 50 feet west of the extended western curb line of Maybrook Avenue to 50 feet east of the extended eastern curb line of Maybrook Avenue.
3a	<u>INSTALL:</u> No Stopping School Days 8AM - 4PM	<u>In Silver Spring:</u> on the south side of Plyers Mill Road from 50 feet east of the extended eastern curb line of Maybrook Avenue to 370 feet east of the extended eastern curb line of Maybrook Avenue.

	<u>REMOVE:</u> (T.O. 107-02, 10a) No Stopping Any Time	<u>In Wheaton/Glenmont:</u> on the west side of Brunswick Avenue from 20' north of the school crosswalk at Harmon Road to Harmon Road.
5a	<u>INSTALL:</u> No Stopping Any Time	<u>In Silver Spring:</u> on the west side of Brunswick Avenue from 35 feet north of Harmon Road to Harmon Road.
6a	<u>INSTALL:</u> No Stopping Any Time	<u>In Silver Spring:</u> on the east side of Brunswick Avenue from 15 feet south of the extended northern curb line of Harmon Road to 35 feet north of the extended northern curb line of Harmon Road.
	<u>REMOVE:</u> (T.O. 107-02, 4a) Right Turn Only 8AM - 4PM School Days	<u>In Wheaton/Glenmont:</u> from the easternmost driveway to Oakland Terrace Elementary School at Plyers Mill Road.
7a	<u>INSTALL:</u> Right Turn Only 8AM - 4PM School Days	<u>In Silver Spring:</u> from the easternmost driveway to Oakland Terrace Elementary School at Plyers Mill Road.
