1. Pursuant to Section 49-53 of the Montgomery County Code (2004) as amended, a public hearing shall be held before the County Executive (or his designee) at 8:00 p.m. on Wednesday, February 27, 2013, in the Lobby Level Auditorium of the Executive Office Building (EOB) located at 101 Monroe Street, Rockville, Maryland. The purpose of this hearing is to consider a proposal to implement safe pedestrian travel along the north side of Hayden Drive from Kohler Road to entrance of Flora M. Singer Elementary School, located in Silver Spring, Maryland within Election District 13 by constructing:

A new concrete sidewalk along the north side of Hayden Drive from Kohler Road to entrance of Flora M. Singer Elementary School, located in Silver Spring, Maryland, under Capital Improvement Project #0506747 (Annual Sidewalk Program). The sidewalk will be five feet wide and will conform to ADA requirements. The total length of the sidewalk is 280 linear feet. Hayden Drive has a 50 foot wide public right-of-way and the existing roadway is approximately 26 feet wide. There is approximately 12 feet of available public right-of-way on the north side of Hayden Drive. There will be a four foot greenspace located between the new sidewalk and edge of roadway. Every effort will be made during construction to cause minimal disturbance within the public right-of-way and to the adjacent properties.


