[ARTICLE II. TAXICAB LICENSE, SEC.53-110 CUSTOMER SERVICE REQUIREMENTS — REGULATIONS

COMCOR 53.110.01 Taxicab Geographic Areas of Service

53.110.01.01 Background Information

The Montgomery County Code Chapter 53, Section 53-110(b)(3) requires that a regulation be enacted to define taxicab geographic areas of service.

The purpose of the regulation is to establish specific boundaries for taxicab service. Fleets and associations will be required to provide customer service data for each of the defined geographic areas. The specific requirements for the customer service data appear in a separate regulation.

53.110.01.02 Geographic Areas of Service

The following seven (7) geographic areas of taxicab service are established as follows:

1. Area 1 (Total Population 141,255)

Taxicab Geographic Areas — Poolesville, Dickerson, Beallsville, Boyds, Darnestown, Germantown, Seneca, Barnesville, Martinsburg, Little Bennett, Goshen, Clarksburg, Damascus, Patuxent, and Mount Airy

Zip Codes — 20874, 20837, 20839, 20842, 20838, 20841, 20876, 20871, 20872, and 21771

2. Area 2 (Total Population - 144,595)

Taxicab Geographic Areas — Gaithersburg, Gaithersburg City, Montgomery Village, and Upper Rock Creek

Zip Codes — 20878, 20877, 20879, 20886, and 20882

3. Area 3 (Total Population - 170,220)

Taxicab Geographic Areas — Laurel, Olney, Brookeville, Ashton, Brinklow, Burtonsville, Cloverly, Four Corners/Kemp Mill, and Colesville

Zip Codes — 20833, 20862, 20832, 20860, 20861, 20905, 20866, 20707, and 20904

4. Area 4 (Total Population - 115,575)


