1. Pursuant to Section 49-54 of the Montgomery County Code (2004) as amended, the County Executive hereby finds that public interest requires construction of a sidewalk to provide safe pedestrian travel along the east side of Garland Avenue from Maplewood Avenue to 7807 Garland Avenue and on the west side of Garland Avenue from 7812 to 7804 Garland Avenue, located in Silver Spring, Maryland within Election District 13. A Public Hearing was conducted on the project at 6:00 p.m. on Wednesday, October 2, 2013, in the First Floor Auditorium of the Executive Office Building (EOB) located at 101 Monroe Street, in Rockville, Maryland. The Hearing Examiner recommended approval of the project and the Director of the Department of Transportation is hereby authorized to proceed with implementing the sidewalk under Capital Improvement Project No. 0506747 (Annual Sidewalk Program).

The sidewalk will be five feet wide and will conform to the Americans with Disabilities Act (ADA) requirements. The total length of sidewalk along Garland Avenue is approximately 260 linear feet on the east side and 260 linear feet on the west side. Garland Avenue is classified as a residential roadway with a 40 foot wide public right-of-way. The existing roadway is approximately 22 feet wide and there is approximately 9 feet of available public right-of-way on both sides of Garland Avenue. There will be a variable width greenspace of zero to three feet wide between the new sidewalk and the edge of the roadway. Every effort will be made during construction to cause minimal disturbance within the public right-of-way and to the adjacent properties.

2. Estimated cost of the proposed improvement and funding allocations thereof are as follows:

A. East Side – (Maplewood Avenue to 7807 Garland Avenue)


