## **VII. Committee Reports**

### **A. Legislative and Policy Planning Committee – Maura Lynch, Chair**

The legislative committee would like to formally ask the DVCC to support the Criminal Law - Sexual Crimes - Repeal of Spousal Defense bill. Currently, Maryland allows marriage to be a defense to some sex crimes including rape when someone is incapacitated or cognitively impaired. Smita will send out more information in the coming weeks.

Debbie Feinstein mentioned that SB20/HB284 - Criminal Procedure - Out of Court Statements - Child Victims and Witnesses bill, which expands the tender years exception to the hearsay rule to include alleged victims and witnesses of crimes of violence who are under 13 years old will go into effect on October 1<sup>st</sup>. This will now allow pre-trial statements to be heard in court from a child who witnessed domestic violence.

Smita Varia also mentioned the bill that was passed by the County Council that will offer rebates and vouchers for installing security cameras. This will be helpful for domestic violence victims because security cameras are the most common requested item for the Emergency Relief Fund from the Family Justice Center Foundation.

### **B. Victim Services Committee update – Tom Manion, Chair**

Tom Manion reported out on updates with the Victim Services Committee. They focused the meeting on legal services. Maura Lynch is working on launching Expungement clinics for survivors of domestic violence. Colleen Bokman also raised the issue of the lack of attorneys to help with protective order cases and Family Law cases including divorce and custody. The committee would like to reach out to law students to take protective order cases under the supervision of an attorney. Tom Manion also mentioned looking into a certification process where attorneys could take a training to get certified to work with DV clients and then make a commitment to take cases.

The committee has also made a connection with the ACCESS program to connect survivors with services to address addiction.

### **C. Education and Outreach Committee – Debbie Feinstein, Chair**

Debbie Feinstein reported on events the Education and Outreach Committee is planning for October's Domestic Violence Awareness Month. There will be a Proclamation presentation on October 4<sup>th</sup> with the County Council and the County Executive. There will be displays that tell a survivor's story and display a pair of shoes called "In their shoes." These posters along with FJC outreach cards will be displayed around the County. Smita Varia sent out a template email to the Council asking them to spread the word.

Tondalayo Royster is working on a new Apartment initiative called Safe Homes, Safe Communities. The goal of this initiative is to work with apartment complexes and offer workshops on domestic violence, bystander intervention and tenants rights and to make sure the FJC awareness cards are available.
