Meeting Minutes

Purpose of Meeting: Sixty first meeting to review the County's response to domestic violence and present committee reports. William Sollod, DVCC Vice Chair, convened the meeting at 5:30 PM.

I. Welcome and Introductions

William Sollod welcomed all members and guests.

II. Approval of September Minutes

The minutes from September 8, 2016 DVCC meeting minutes were reviewed. A motion was made to approve the minutes without revision, and the motion was seconded and passed.

III. Announcements

William Sollod welcomed guest DVS Legal Services to share a presentation regarding services provided at the FJC.

IV. DVS Legal Services, Inc.

Amy Shaw Palumbo and Donna Rismiller shared that DVS Legal Services ("DVS") is a new onsite FJC partner. DVS' mission is to increase access to legal resources for families impacted by domestic violence. DVS works with partners on site at FJC as well as other agencies to connect survivors with legal representation for protective order, divorce and custody cases. DVS has been onsite at FJC for approximately two months and has experienced a high rate of success connecting clients with legal representation. Debbie Feinstein shared information regarding JCADA's resources that may complement DVS.

V. Committee Reports

A. Education and Outreach Committee

Debbie Feinstein shared updates for Choose Respect Conference. The date has been set for April 2, 2016 at Richard Montgomery High School. Members of the committee are talking with JCADA and MCPS to increase awareness and attendance for the conference. Debbie Feinstein and Tom Manion attended the recent SCUP conference and received requests from many professionals to share the Expect Respect curriculum. The committee has reshaped the Choose Respect Conference, PSA Contest, Expect Respect (in class curriculum) and Coaching Boys Into Men initiatives to be promoted together under the Choose Respect brand.

B. Victim Services Committee

Cheryl Kravitz shared that DVS is a new onsite partner at FJC and that the Domestic Violence Fatality Review Team has reconvened meetings each month. The Honorable Karla Smith shared information regarding the Interfaith Domestic Violence Coalition conference on November 9, 2016. The coalition includes judges in jurisdictions across Maryland heading up local initiatives. Judge Smith led the break-out session devote to Montgomery County resources. Tom Manion (Montgomery County Office of the Sheriff), Jordan Satinsky (Montgomery County Police), Wendy Grier (Child Welfare Services) and other local representatives from Montgomery County shared information regarding resources available in the county.

C. Offender Program and Policy Committee

William Sollod shared that the committee is interested in hosting an

offender roundtable meeting. Tina Michaels shared that information and needs from prior offender roundtable meeting.

D. Legislative and Policy Planning Committee

Dorothy Fait was not present. Members present discussed needs that may be considered for future legislation. Some concerns that members highlighted are the need for penalties for offenders putting tracking devices on victim's vehicles, breaking victim's cell phones, and registering antique/replica firearms (currently an exception to statute requiring registration for firearms).

E. MCFJC Foundation

The MCFJC Foundation Annual Benefit was held October 30 at the Hilton in Rockville. Amy Shaw Palumbo shared that \$25,300 was raised at the appeal, \$2075 was raised through the new "purple shop", and \$7,550 was raised through the live auction.
