SUBJECT: DFRS Logo License Plates

The Division of Fire and Rescue Services, in cooperation with the Maryland Motor Vehicle Administration, is making Division logo license plates available to all DFRS personnel. These license plates consist of a two inch by three inch, four color Division logo design, followed by the initials MC and a four digit number. The top of the plate reads "Maryland", with the bottom reading "Div. Of Fire & Rescue", (see attached example).

The following guidelines apply to the issuance of Division license plates:

1. The cost of the plates is \$25.00 per vehicle.
2. License plates will be made available to current and retired DFRS personnel only.
3. The plates must be assigned to a vehicle registered to the DFRS member or their spouse.
4. The Division reserves the right to deny the issuance of plates based on a member's driving record, or at the discretion of the Division.
5. The Division reserves the right to revoke any issued plate for cause.

If you would like to request a set of plates for your vehicle, please use the following procedures:

1. Complete an MVA Form VR 124 clearly (see attached example). This form is available through the Bureau of Program Support Services. Forward the completed form by **U.S. Mail** to:

2. Include a check with your MVA form in the amount of \$25.00 per set of license plates. The check should be made payable to the Motor Vehicle Administration.
3. The new license plates will be sent to the employee's residence. It will be the member's responsibility to turn-in their old plates to any full service MVA office within 48 hours.
