BACKGROUND: The proposed regulation delegates the responsibility for administering the LOSAP program to the Fire Administrator, in coordination with the Fire and Rescue Commission and other appropriate Montgomery County agencies. The LOSAP program is to be administered in accordance with Executive Regulation 17-00 and the requirements of Code Section 21-21(h)(1).


Sec. 1. Assignment of Responsibility. The County Executive assigns the responsibility for the administration of the Length of Service Awards Program to the Fire Administrator, in coordination with the Fire and Rescue Commission and other appropriate Montgomery County agencies. The regulation must be administered in accordance with the requirements of Executive Regulation 17-00 and the County Code.

Sec. 2. Effective Date. This regulation is effective when the Council receives a copy of the regulation adopted by the County Executive.


