- Appointments conducted entirely online. NO IN-PERSON CONTACT REQUIRED.
- Securely upload your required tax documents without leaving your home.
- **All VITA sites serve taxpayers filing with ITINs.** Staff available to help submit ITIN applications at CASA during the tax season and at Community Action during the post season (July – October).
- Certified tax preparers complete and file your taxes FOR FREE.
- Appointments available to prepare 2021 federal and state returns.
- For Montgomery County residents only (including ITIN holders) with household incomes of \$58,000 or less.

WHAT TO BRING: PREVENT FRAUD & IDENTITY THEFT

The IRS Does Not Allow VITA to prepare taxes without the required documentation

- ✓ Valid Government Issued Photo ID (NO COPIES)
- ✓ Original Social Security Card or Individual Tax Identification Notice (ITIN) for everyone in your family
- ✓ Last year's tax return (if available)
- ✓ All W2 forms, forms 1098-T, 1099-MISC, 1099-K and other documents regarding income
- ✓ If filing jointly, your spouse must be present. If filing separately, you must bring your spouse's Social Security Number and name just as spelled on Social Security card
- ✓ Statement of annual child care expenses prepared by the provider, with their tax ID (Social Security or EIN number)
- ✓ Health insurance information from your employer, the marketplace (ACA), Medicaid or Medicare, and form 1095-A, or B or C
- ✓ **For Direct Deposit: Proof of a bank account, including routing numbers. Or, ask about Bank On!**
