Opening Business: The meeting started late due to technical difficulties. Megan welcomed the new Wheaton Branch Supervisor, Gretchen Benson, who will attend the LAC meetings moving forward. Megan then called the meeting to order at 7:30 pm and asked for approval of on the September 2025 minutes. Ania moved to approve and Andrew seconded the move to approve the minutes. The September 2025 minutes were then unanimously approved.

Membership Update: Megan shared the November 2025 approval of a new Wheaton LAC member, Sidra Jeffries whose term is from October 2025-October 2028.

Wheaton Library Managers Report to the LAC

Gretchen Benson shared the Agency Manager's Report for November 17, 2025.

Collection:

- We are focusing on marketing, specifically how we display items, the materials used, and their duration.
- We now have Video games for customers. The systems are XBox, Playstation 5, and Nintendo Switch.

Building:

- Our Collaboration Room #1 ceiling has been fixed. It was out of use for almost 2
 months- but it is functioning now. Community is very happy to be using all the rooms
 again.
- We also had facilities look at the glass folding doors in the Children's Programming Space. They are still working out a solution for those.
- We now have a broken upper window along Arcola (this happened this afternoon).
 Maintenance has already been out to look at what is happening.

Programming:

 Wheaton Library just finished presenting the Hatchlings Program. Our event immediately filled up with new parents. It's a 3-week program designed for expectant families and babies 0-4 months and their parents/guardians. Each interactive session is designed to stimulate babies' learning process, and each session builds on the previous session.

Upcoming Programs:

- **Kids** We are ending the year with a presentation by a Magician, Mike Rose. He is coming on December 28th and we are partnering with the Rec Center to promote the special programs we are doing for the time between the end of year holidays.
- **Teens** At the December Teen Advisory Board meeting the Teens will be working with the Montgomery County Community Cat Coalition to build shelters that can be used for stray or feral cats
- Adults We are working with C2C (Classroom to Community) to offer some Job Success classes. We had one today on Nov 17th about Job Searching Success. The next one is how to Network happening Dec 1st (3-5pm)
- Big Events The Local Author Showcase (1st Annual). It will be November 22nd in the Rec Center Gym and Social Hall.

Library Liaison Report

Grace Manubay shard that the Library Board held a joint meeting with Friends of the Library, Montgomery County on Oct. 8. The meeting included a guest speaker from the Freedom to Read Foundation, which was established by the American Library Association. She discussed collections management on a national level, and how library collection policies are protected by First Amendment rights and reflect the local community.

MCPL's collection manager, Felicity Brown, then described our collections policy. We hope to have a meeting summary posted on the library website soon. Attendance for the meeting was split evenly between in-person and hybrid.

We will have another joint meeting at the Rockville Library on Wednesday, Jan. 14. The topics will center around advocacy efforts and how LACs can support the library during the upcoming budget season.

The library recently released its annual report. Hard copies will be available in branches and I will share the digital copy once it is available. Prior to the meeting, I also sent around the Director's report for reference.

Nov. 22 is also the Local Author's showcase at Wheaton, which will be from 12-5pm.
