



MONTGOMERY COUNTY EMPLOYEES' RETIREMENT SYSTEM

July 1, 2019

Effective July 1, 2019 eligible retirees, and others receiving annuity payments from the Montgomery County Employees' Retirement System (ERS), will receive a Cost-of-Living-Adjustment (COLA). The amount of the adjustment is based on the change in the Consumer Price Index-All Urban Consumers, Washington-Arlington-Alexandria, DC-VA-WVA (CPI-U) from May 2018 to May 2019.

Shown below is the percentage that each retirement benefit will change based on the plan and retirement date:
