4. Assign a driver training mentor.
5. Establish a schedule for driver training, goals, and projected completion date.

- \_\_\_\_\_ 2. Successfully complete a minimum of one hour practical driving experience on public roadways.
- \_\_\_\_\_ 3. Successfully complete a minimum of one hour practical driving experience off-road.
- \_\_\_\_\_ 4. Successfully complete the written test for Brush Truck operator, with a passing score of 70% or higher.
